I requested through a Sgt at Pistol License Section to put over the "teletype" and to be read at ten roll calls, that many renewed permits are still not issued. Supposedly Patrol has been notified of the dilemma. "Be guided accordingly." Yes I know they all have "Smart Fones". Further on, regarding this issue being invited to 1 PP and speaking with Deputy Commissioner of Administration, Robert Ganley. The following information was obtained from the "Better Business Bureau". Please read the info and pass it along to your family and friends. As times change the scams get more and more sophisticated. We have to remain vigilant and aware of all types of threats.

The Better Business Bureau Releases Top Scams of 2017. Read to Prevent Becoming Victim to These Common Scams.

According to the Better Business Bureau the following are the Top Scams of 2017. Many are new twists on existing scams, but scammers become more sophisticated every year in how they spoof trusted brands and how they fool consumers.

1. Internal Revenue Service (IRS) - Scammers posing as IRS agents claim you owe back taxes and threaten lawsuits and arrest if payment is not sent immediately. Keep in mind, the IRS does not make threatening phone calls, nor do you send payment via unconventional methods such as gift cards or wire transfer.
2. Sweepstakes/Lottery/Prizes - Winning the sweepstakes, dream vacation, large amounts of money, a new car, shopping spree or new technology sounds great especially if you didn't enter to win. Unexpected prize and lottery scams rely on your excitement to lure you into paying fees for your prize or and typically require that you provide your personal information with the intent of compromising your identity. Remember, you should never have to pay fees for winning a prize. You will also never win a lottery you never entered.
3. Government Grant - Victims receive a phone call, email or letter stating they qualified for a government grant, but to receive the grant you must pay the processing and/or delivery fee via wire transfer or prepaid debit card. Never send money by wire transfer or prepaid debit card to somebody you don't know or haven't met in person.
4. Auto Warranty - You receive a letter in the mail that your auto warranty has expired, but you have a limited amount of time to extend your warranty for a low cost. Often times you'll receive more than one letter that extends the time for you to get that low price. Check with bbb.org before purchasing another warranty from a company.
5. Tech Support - Consumers are being targeted by fraudsters pretending to be well-known tech support companies. Victims are contacted with a message on their computer that a virus has been detected and to "fix" the problem, a phone number or website is given to purchase an anti-virus computer via debit or credit card. Computer manufacturers will not contact you to let you know if there is a problem with your computer.

6. Phishing/Smishing- You receive an email or text telling you that you've won a contest, a business or someone posing as an official at your place of employment needs to verify your personal information, such as your Social Security number. Never click on links or open attachments from unsolicited emails and never provide personal information without first verifying the source.
7. Employment - Scammers advertise a job opening or guarantee job placement if you pay a fee to cover the cost it takes to place you in a job. However, after you pay, there's no job and you are out of money. Remember, if a potential employer asks you to pay the company to cover the costs of testing, training or background checks, consider it a red flag.
8. Advance Fee Loan - Advance fee lenders charge an upfront fee and will "guarantee" you a loan despite your credit history and chances are you won't get your money back. Legitimate financial organizations will always check your credit history. A lender who isn't interested in your credit history is an immediate red flag.
9. Bogus Online Retailers - You see a highly sought-after item for a discounted price or a puppy too cute for words. You wire the money or pay via pre-paid credit card. The money is gone, you have no items, and the retailer is nowhere to be found. Always use caution when dealing with unfamiliar online retailers. Read reviews at bbb.org to make sure you are dealing with a business you can trust.
10. Medicaid/Medicare Scam - You are contacted by a government authority who claims they wish to send you a free gift for updating your account information. You soon discover you never received the gift and your identity has been compromised. Never provide personally identifiable information to an unsolicited phone call or email without first verifying the source.
11. Travel/Nacation Scams - Con artists post listings for properties that either aren't for rent, don't exist, or are significantly different than pictured. They then lure in vacationers with the promise of low fees and great amenities. Another common travel scam is the timeshare resale con. A timeshare owner who is looking to sell gets a call from someone claiming to be a real estate broker or agent. These scammers claim to specialize in timeshare resales and promise they have buyers ready to purchase. To secure this service, the scammer pressures the target into paying an upfront fee. The timeshare owner pays up, but the reselling agent never delivers. You should never pay for a vacation rental by prepaid debit card or wire transfer. These payments are the same as sending cash. Remember, if it's too good to be true it probably isn't.
12. Identity Theft - These scams are designed to either steal your money now, or steal your identity now in order to steal your money later. Scammers have all kinds of techniques to collect personally identifiable information. Once they have it, they can effectively become you, using your identity to open accounts, file taxes, or obtain medical coverage. Look for unexplained withdrawals, charges, and accounts. Also, check your credit reports regularly for unauthorized inquiries and accounts.
13. Phony Debt Collection - The scammer calls and tells you that they work for a loan company, law firm or government agency, and claims to be collecting an overdue payment. When you reply that you don't owe money, the "debt collector" starts to make threats of suing you, having your wages garnished, arresting you, or forcing you to appear in court thousands of miles from home. Despite the threats, these "debt collectors" don't have any legal power. In most cases, the alleged overdue loan doesn't even exist. Don't give in and pay money you don't owe. If you do, the scammer will likely be back for more.
14. "Can You Hear Me?" - You get a call from someone who almost immediately asks "Can you hear me?" Their goal is to get you to answer "Yes," which most people would do instinctively in that situation. There may be some fumbling around; the person may even say something like "I'm having trouble with my headset." But in fact, the "person" may just be a robocall recording your conversation... and that "Yes" answer you gave can later be edited to make it sound like you authorized a major purchase. Use Caller ID to screen calls, and consider not even answering unfamiliar numbers. If it's important, they will leave a message and you can call back. If someone calls and asks "Can you hear me?", do NOT answer "yes." Just hang up.

To All Our Members Living Outside The New York Area Who May Have GHI Medical coverage and have a problem locating In Network Providers. The following is a response from GHI to a friend, living outside the New York area, re: his complaint regarding the use Out Of Network providers. Subject: Your City of New YorkCorrespondence #1-1-1538291274
Message to Agency Head, OLR - Health Insurance Benefits

Dear Mr. (Name Deleted),

We appreciate you reaching out to us about the services that you received from the GHI/Comprehensive Benefits Program/Empire Blue Cross Blue Shield Plan (GHI-CBP) provided through the New York City Health Benefits Program.

Through collective bargaining agreements, the City of New York and the Municipal Unions have cooperated in choosing health plans and designing the benefits for the City's Health Benefits Program. These benefits are intended to provide you with the fullest possible protection that can be purchased with the available funding.

You are currently enrolled in the GHI-CBP health plan. The GHI-CBP is one of many health plans available to City employees, non-Medicare retirees and their dependents. The Health Benefits Summary Program Description (SPD), available on the Program's website at nyc.gov/hbp, provides information on all of the health plans along with explanations on how and when you are eligible to transfer health plans. The health plans differ with regards to plan type (PPO or HMO), network use (in-network only or available out-of-network coverage), provider service area (regional or nationwide), and cost (\$0 employee basic plan premium or employee premium payroll/retiree pension check deduction). In addition, posted on the Health Benefits Program website is the federally required Summary of Benefits and Coverage (SBC) for each plan that is available for City employees and non-Medicare retirees. The SBCs allow City employees and non-Medicare retirees to compare healthcare services among the various health plan options using an "apples to apples" comparison so that they may select the right plan for them. With regards to selecting a health plan, Page 4 of the SPD states the following:

To select a health plan that best meets your needs, you should consider at least four factors:

Coverage - The services covered by the plans differ. For example, some provide preventive services while others do not cover them at all; some plans cover routine podiatric (foot) care, while others do not.

Choice of Doctor - Some plans provide partial reimbursement when nonparticipating providers are used. Other plans only pay for, or allow the use of, participating providers. Convenience of Access - Certain plans may have participating providers or centers that are more convenient to your home or workplace. You should consider the location of physicians' offices and hospital affiliations.

Cost - There is no cost for basic coverage under some of the health plans offered through the City Health Benefits Program, but others require a payroll deduction. Additional benefits (e.g., prescription drug coverage) may be available through an Optional Rider. These costs are compared on the rates charts which are available on the Health Benefits Program Web site at . Some plans require co payments for certain services. Some plans require you to pay a yearly deductible and coinsurance before the plans will reimburse you for the use of nonparticipating providers. If a plan does not cover certain types of services that you expect to use, you must also consider the out-of-pocket cost of these services. The plan you have chosen will send you information regarding your health benefits coverage when you enroll.

The GHI-CBP is a Preferred Provider Organization (PPO) which means that it offers members the opportunity to use in-network primary and specialist providers, without a referral. In addition, as stated on Page 43 of the SPD, GHI-CBP offers "payment for services provided by out-of-network providers made directly to you under the NYC Non-Participating Provider Schedule of Allowable Charges (Schedule). The reimbursement rates (allowed amounts) in the Schedule are not related to usual and customary rates or to what the provider may charge but are set at a fixed amount based on GHI's 1983 reimbursement rates. Most of the reimbursement rates have not increased since that time, and will likely be less (and in many instances substantially less) than the fee charged by the out-of-network provider. You will be responsible for any difference between the provider's fee and the amount of the reimbursement; therefore, you may have a substantial out-of-pocket expense. If you intend to use an out-of-network provider, you can call GHI-Emblem Customer Service with the medical procedure codets (CPT Code) of the service(s) you anticipate receiving to find out what you would be reimbursed."

To avoid the expense of using out-of-network providers, you should speak with your current local doctors and request that they apply to become GHI-CBP in-network providers.

In the alternative, as stated above, you have the option to transfer health plans. For non Medicare retirees that reside outside of the New York City Metropolitan area, in addition to GHI-CBP, the following health plans, listed on Page 27 of the SPD, are available for you to enroll in:

We understand that selecting a health plan that best meets your needs is a difficult decision. However, we are here to help. New Gun Licensing Procedures at the NYPD

PLEASE TAKE NOTICE: Effective January 1st, 2018 the NYPD License Division began new procedures to renew your current licenses for both Handgun licenses and Rifle/Shotgun permits. It also applies to new license applications. It is a paperless process. It requires you to fill out and submit the forms, pictures, and payments [online](#).

According to the License Division, about one (1) month before your license is due to expire, you will receive a letter in the mail from the License Division. It will contain a unique identification number specific to you. Please keep their letter until you have completed the entire process. You will need the identification number and the online address they provide to log in to the License Division system. Follow their instructions to complete and submit your application and related paperwork.

For those of you without internet access, please ask a relative or close friend with internet access, to assist you. If that is not possible, the Club plans to set-up a computer at the range to assist in the renewal process. You are responsible for submitting the required documents with the correct information.

I'm sure you have many questions about the process including: signatures, notarization, payments, and photos. Read and follow the instructions online.

We don't have all the answers yet. Problems will come up and it will probably take several months to work them out.

MEDICARE ISSUING NEW ID CARDS IN 2018

REMOVING SOCIAL SECURITY NUMBERS TO
PREVENT IDENTITY THEFT AARP, MARCH 17, 2017

Medicare 10 cards will remove Social Security numbers in 2018. Medicare is preparing to stop using Social Security numbers for identification next year and will send new cards to patients with Medicare 10 numbers. The move is required by a law enacted two years ago to discourage identity theft.

The Centers for Medicare & Medicaid Services (CMS) recently updated its web page to help health care providers prepare for the change. The agency plans to begin mailing the new cards with Medicare beneficiary identifiers (MBIs) in April 2018. During a transition period through 2019, providers can use the MBIs or health insurance claim numbers (which are based on Social Security numbers) on transactions such as billing and claims.

The 2015 law, the Medicare Access and CHIP Reauthorization Act, requires CMS to remove Social Security numbers from Medicare cards by April 2019.

"We're now figuring out the best way to mail the cards," the agency advised providers. "We'll keep you posted about critical information so you can be ready to ask your Medicare patients at the time of service if they have a new card with an MBI."

CMS plans a "wide-scale outreach" to let beneficiaries know that they need to bring their new Medicare cards when they get care and how to get MBIs if they lose their cards.

AARP's Fraud Watch Network ambassador, Frank Abagnale, advises consumers not to share Social Security numbers unnecessarily. "And don't carry your Medicare card unless you are on your way to a health care appointment," he wrote last year. "Instead, make a copy and black out all but the last four digits."

IMPORTANT INFORMATION ON MEDICARE PART B REIMBURSEMENTS

It has been brought to our attention by the City's Office of Labor Relations (OLR) that the Medicare Part B reimbursement amounts that will be issued to PBA Members during April 2018 may be less than what our Members paid in standard Medicare Part B premiums, excluding penalties. Therefore, you may be eligible for additional reimbursement.

This applies to individuals who fit at least one of the following criteria:

- Your 2017 monthly Medicare Part B premium was between \$110.00 and \$134.00.
- Your Medicare Part B, and/or your dependent's Medicare Part B, effective date is prior to 2016.
- You and/or your dependent did not receive Social Security benefits; therefore, you were billed directly for Medicare Part B Premiums.
- You were newly enrolled in Medicare Part B in 2017 and did not receive the higher reimbursement because you are a Line of Duty Survivor.

In the coming weeks, you will be receiving an important letter from the City regarding the Medicare Part B premium reimbursement discrepancy. By the time you receive the City's letter, you should have already received your Medicare Part B reimbursement, either through direct deposit to your bank account, or in the form of a check by mail. We urge you to follow the instructions which will be provided to you in the City's letter.

We will keep you apprised of any additional developments concerning this matter.

NYPD PISTOL CARRY PERMIT LIST OF PARTICULARS

You will receive a letter 2 to 4 weeks before your expiration date describing how to get onto NYPD application renewal web site to renew your carry permit. After your application is complete you will receive an e-mail of acceptance. Your renewed Pistol License will come to via USPS within 2 to 4 weeks later. Yes your license - will have expired, but patrol force has been notified of the dilemma.

- a) Your name
- b) Your status as retire
- c) Your pin. This is needed to continue returning to your personal renewal application.

You will need to copy and upload the following:

- 2) Driver's License (obverse and reverse)
- 3) NYPD ID Card (obverse and reverse)
- 4) Current Pistol License (obverse and reverse)
- 5) Letter from spouse / significant other having "no objection to having a firearm in our house"
- 6) Request for "Public records exemption of publication"
- 7) Statement you are familiar with the Penal Law regarding falsified statements and about safeguarding a firearm.
- 8) Photoes of your safe with the open door and closed door if you have five or more firearms.
- 9) Birth Certificate
- 10) Social Security Number
- 11) DD 214 if applicable

GOOD INFORMATION. PLEASE READ AND MAKE A COPY FOR YOUR FILES

IF A MEMBER DIES - INFORMATION TO THE SURVIVING SPOUSE OR FAMILY **(Hopefully Not Needed For A Long Time)**

Too often spouses and families are left in a quandary upon the death of a loved one. Few situations in life are more stressful than when a spouse passes. All too often we have a difficult time focusing on the issues at hand and need guidance to get the deceased affairs in order. The following is a general guide for the widow(er) or the deceased's family regarding important notifications that must be made by the surviving spouse and information you should have on hand when a retiree dies.

I. PREPARATIONS BEFOREHAND

- **GATHER ASSETS** - This doesn't mean piling them all together. It means getting a list of all the assets at the time of the decedent's death, along with copies of statements, deeds, etc. This information is needed for probate. It's also essential for filing federal and state estate tax returns, if required.
- **REVIEW IRAs** - If the surviving spouse is the beneficiary, decide whether to roll an IRA over to the surviving spouse.
- **GET GOOD ADVICE** - and get it now. The money you pay to attorneys and other advisers to resolve issues NOW can be much lower than if you deal with problems AFTER a person's death.
- In case of couples, usually most of the property is held in joint names and the survivor obtains same "by operation of law" However, there may be some items which were held in the name of the deceased only, and in that case it would be necessary to go to Probate Court to transfer ownership of that property, unless listed in a trust.
- **GET ORGANIZED NOW** - When someone dies, one of the big problems for beneficiaries is locating the things necessary to settle the estate. Make sure you know before the death occurs where to find the following documents and information. (This is just a partial list)

- Will
- Living Will
- Trusts
- Deeds (if any)
- Safe-deposit boxes (location of boxes, contents and keys)
- Life insurance policies
- Funeral and burial instructions
- Names and addresses of creditors and debtors
- List of assets and where they are located
- List of all advisers (attorney, accountant, insurance agent, stockbroker, etc.)

II. STEPS TO BE TAKEN AFTER DEATH - Notifications to be made:

Contact the appropriate Union for a possible existing life insurance policy and also for continuation of optional benefits, if qualified.

- Detectives - Detectives' Endowment Association (DEA) at (212) 587-9120
- Sergeants - Sergeant's Benevolent Association (SBA) at (212) 431-6555
- Lieutenants and above - Superior Officers Council (SOC) at (212) 964-7500

2. Contact the NYC Health Benefits Program for Special Continuation of Coverage application (coverage for life) located at 40 Rector Street, 3rd Floor, New York 10006 (212) 513-0470.

3. Contact the NYPD Operations Unit located at One Police Plaza at (646) 610-5580, for pall bearers (Funeral Director will usually do this for you) for all five boroughs, all of Long Island and Upstate New York, but not beyond Dutchess County.

4. Contact Social Security: (800) 772-1213 (Funeral Director will usually do this for you)

5. Contact Fraternal Organizations to arrange for visitors, Color Guard and possible insurance benefits

6. If a veteran, notify the Veterans Administration at (800) 827-1000 for: Grave marker, Funeral Allowance and Flag (Funeral Director will usually do this for you). If can't find discharge papers or DD 214, you will need date of Enlistment, date of Discharge, Branch & Serial Number. If deceased had 100% disability for 10 years, spouse is entitled to an additional benefit.

7. Notify your Church or Temple for announcements and to arrange for funeral. (Funeral Director will usually do this for you). Health Insurance: COBRA (Consolidated Omnibus Budget Reconciliation Act of 1985) COBRA has a safety net. If spouse or dependent was covered under deceased's health plan they may continue coverage under COBRA for up to 36 months. New York State in 2001 amended the Administrative Code to continue Health Care Coverage for Surviving Spouses for Life (Download Information Regarding this Amendment). This enables the deceased's spouse and/or dependents to receive coverage at the group rate. The City and the Line Organization health benefits stop at the death of the members. The rate, though high, is cheaper than the non group rate. Call: NYC Employee Benefits (212) 513-0470

THINGS YOU WILL NEED DEATH CERTIFICATES - Death Certificates are necessary in every step to the successful administration of a decedent's estate. (Usually Funeral will obtain certificates as part of his service at current cost). They are usually needed for:

- Pension Bureau Veterans Administration (if a veteran)
- Motor Vehicle Bureau if auto was in deceased's name. 1 for each insurance policy
- Court (If probate is needed)
- Your State Department of Revenue to obtain non-tax certificate if real property is involved.
- Bank accounts held in Trust for another 1 for each account if property held in a Trust
- Personal Records

Note: If estate is probated, some of the above will take a Letter Testamentary instead of a Death Certificate.

MARRIAGE CERTIFICATE (With Official Raised Seal): Social Security, (not necessary if surviving spouse already receiving benefits) Veterans Administration, if a veteran.

LETTERS TESTAMENTARY or LETTERS OF ADMINISTRATION: Motor Vehicle Bureau, if auto is in the deceased's name. One for each bank account Brokerage house account (share of stock or bonds, etc. that were in the deceased's name alone)

DISCHARGE PAPERS: DD 214 - (Original needed) Social Security, if spouse was not already receiving benefits. Remember that service time counts toward qualification. They will Photostat. Veterans Administration, if a veteran

PAID FUNERAL BILLS: 1 copy for Pension Bureau 1 copy for Probate Court 1 copy for IRS, if taxable estate.

OTHER THINGS THAT MAY APPLY (usually after burial)

Cancel any leases. (If your parent or loved one rented a home, cancel the lease after clearing out the furnishings)

Inform insurance companies

File life Insurance claims for any policies on the person's life, and request that the insurers send you Form 712, Life Insurance Statement (This is a statement about the life insurance that must be filed with the estate tax return).

Make sure the car insurance company continues to cover the person's car until it's sold or transferred to a beneficiary.

Make sure the homeowners policy continues to provide adequate coverage for the person's things until removed from the home.

Notify companies the person did business with.

Cancel credit cards, and close charge accounts.

Have airlines to transfer frequent-flier miles to the primary beneficiary. (Each airline has different policy concerning this issue. Check with carrier about rules)

Consideration should also be given to making pre-death funeral arrangements. This provision, no matter how painful, should be discussed by couples and by parents with their families. Too often, spouse and children spend much too much money on a funeral and do so without really knowing what were the deceased's wishes in this regard (Place of burial, Cremation, etc.)

Consideration should also be given to having a "Family Durable Power of Attorney" (Someone to take over your finances if you become incapacitated or incompetent)

There are no words of comfort at such a difficult time, however, if you have all the necessary information at the ready it will expedite any claim that is pending, make the process run smoothly, and your stress level can be minimized.

After a while it can be overwhelming and make you cynical. It can even make you hate. Some let it destroy their lives, sometimes it can ruin whole families and rarely is recovery an easy fix. Take heart my friends, like I intimated, the journey was a constant adrenaline rush that few ever regret taking, even though part of it is about rationalizing all of the casualties along the way. All that have ever worn the blue understand my sentiments, it is those that never cradled a dead baby in their arms or saw the poverty that could strip whole generations of their dignity. Those that never stood a post while malcontents stood before them spewing insane vulgarities and hate because of the color of your skin and just as bad the color of the uniform that we wore. They can't possibly comprehend how that affects us. This post was about reflection. I do wish that I could have changed so many of the horrors of society, but realistically, Police Officers might only have the opportunity to actually change a life for the better, occasionally. That's just the way it is! We ALL took the vows and the vows never die! Be grateful for the lessons learned and the friends made!!!
