Our Annual Golf Outing was a great success!!!

The average amount of attendees at our monthly meeting varies between 50 and 70 members, let's all make an effort to bring a friend to the next meeting! Elections are coming up we could use some fresh blood to get actively involved in our club.

Medicare Part D beneficiaries who have high prescription drug expenses currently have to pay more once the total cost of their medicines reaches a certain threshold.

Medicare beneficiaries with high annual prescription drug costs will get some relief a year earlier than expected as a result of the budget deal President Trump signed early Friday.

Part D beneficiaries who have high prescription drug expenses currently have to pay more once the total cost of their medicines reaches a certain threshold. That's due to a quirky aspect of Part D called the coverage gap, also known as the "doughnut hole."

The doughnut hole has been narrowing each year since the Affordable Care Act (ACA) was passed in 2010. The gap was scheduled to close in 2020, when beneficiaries would be expected to pay 25 percent of the cost of all their prescriptions while they were in the gap.

Under Friday's budget deal, the doughnut hole will now close next year. Beginning in 2019, Part D enrollees will pay 25 percent of the cost of all their prescription drugs from the time they enter the gap until they reach catastrophic coverage.

For 2018, the threshold for entering the doughnut hole remains at \$3,750 worth of drug costs. Once a Medicare enrollee passes that limit, he or she is in the coverage gap and will have to pay 35 percent of the cost of brand-name drugs and 44 percent of generics. They will continue to pay those costs until their out-of-pocket spending reaches \$5,000. Once they hit that limit, they'll no longer be in the doughnut hole and will pay no more than 5 percent of their drug costs for the rest of the year.

Congress made the early close of the doughnut hole possible by requiring certain pharmaceutical manufacturers to pay more of the costs for enrollees who are in the coverage gap. Currently, brand-name drugmakers pay 50 percent of enrollees' brand name drug costs while they are in the coverage gap. Under Friday's budget law, they will now pay 70 percent.

News Article Child identity thefts. The new identity thefts are targeting children's Social Security numbers. They open up a line of credit, get loans, and credit cards. The problem is this does not get identified until years later when the children try to open up their own line of credit. They then find out they have bad credit ratings, due to credit cards late payment and or loan defaults. It then takes a lot of effort and money to clear up their names. So what can be done!! A Credit Freeze can be placed on their names and Social Security numbers. This stops anyone from opening up a credit card or loan in their name. Contact the following credit reporting companies and ask for a Credit Freeze. They are : Equifax, Transunion and Experian. This cost no money to place a freeze. The only cost is \$5.00 when and only when you request the freeze to be lifted so an account can be opened IE new credit card or loan when the child is of age. On another note, a bit of information on new Medicare Cards, which many of you already have received.

Protecting Your New Medicare Card

The Centers for Medicare & Medicaid Services [CMS] has begun issuing new Medicare cards starting in April, 2018. Medicare recipients will not all receive their new cards at the same time. "We will be getting our cards according to a state-by-state schedule that will last from April 2018 to April 2019. The new cards will use random numbers instead of your Social Security numbers as your identifiers.

It won't be a foolproof precaution, but it will go a long way toward protecting your identities. It will be up to you to keep your new card safe. The bad guys can still use it to submit fake claims for reimbursement.

Beware new scams, says the Federal Trade Commission, which has offered these guidelines to Medicare cardholders:

- Don't pay for your new card. It's yours for free. If anyone calls and says you need to pay for it, that's a scam.
- Don't give personal information to get your card. If someone calls claiming to be from Medicare, asking for your Social Security number or bank information, that's a scam. Hang up. Medicare will never ask you to give personal information to get your new number and card.
- Guard your card. When you get your new card, safeguard it like you would any other health insurance or credit card. While removing the Social Security number cuts down on many types of identity theft, you'll still want to protect your new card because identity thieves could use it to get medical services.

Verizon Wireless Discount for Retirees

Retired members can receive a 8% discount off their Verizon Wireless monthly bill.

Retired members should contact Verizon Wireless Customer Service at (800) 922-0204 / press option 4 for "Other Options" / hold to speak with an Account Representative and inform them that you are looking to enroll in the retiree discount for law enforcement. You will need to provide them with a Profile ID number; the Profile ID number is 2766591. You will also need to provide them with your account number (this is your 10 digit cell phone number) and your account password. The account representative will give you a couple of options on how you can register on-line for the discount. There are other possible discounts you can sign up for; such as an additional 3% discount by receiving a paperless e-mailed monthly bill.

MEDICARE ISSUING NEW ID CARDS IN 2018

REMOVING SOCIAL SECURITY NUMBERS TO
PREVENT IDENTITY THEFT AARP, MARCH 17, 2017

Medicare 10 cards will remove Social Security numbers in 2018. Medicare is preparing to stop using Social Security numbers for identification next year and will send new cards to patients with Medicare 10 numbers. The move is required by a law enacted two years ago to discourage identity theft.

The Centers for Medicare & Medicaid Services (CMS) recently updated its web page to help health care providers prepare for the change. The agency plans to begin mailing the new cards with Medicare beneficiary identifiers (MBIs) in April 2018. During a transition period through 2019, providers can use the MBIs or health insurance claim numbers (which are based on Social Security numbers) on transactions such as billing and claims.

The 2015 law, the Medicare Access and CHIP Reauthorization Act, requires CMS to remove Social Security numbers from Medicare cards by April 2019.

"We're now figuring out the best way to mail the cards," the agency advised providers. "We'll keep you posted about critical information so you can be ready to ask your Medicare patients at the time of service if they have a new card with an MBI."

CMS plans a "wide-scale outreach" to let beneficiaries know that they need to bring their new Medicare cards when they get care and how to get MBIs if they lose their cards.

AARP's Fraud Watch Network ambassador, Frank Abagnale, advises consumers not to share Social Security numbers unnecessarily. "And don't carry your Medicare card unless you are on your way to a health care appointment," he wrote last year. "Instead, make a copy and black out all but the last four digits."

New Gun Licensing Procedures at the NYPD

PLEASE TAKE NOTICE: Effective January 1st, 2018 the NYPD License Division began new procedures to renew your current licenses for both Handgun licenses and Rifle/Shotgun permits. It also applies to new license applications. It is a paperless process. It requires you to fill out and submit the forms, pictures, and payments online.

According to the License Division, about one (1) month before your license is due to expire, you will receive a letter in the mail from the License Division. It will contain a unique identification number specific to you. Please keep their letter until you have completed the entire process. You will need the identification number and the online address they provide to log in to the License Division system. Follow their instructions to complete and submit your application and related paperwork.

For those of you without internet access, please ask a relative or close friend with internet access, to assist you. If that is not possible, the Club plans to set-up a computer at the range to assist in the renewal process. You are responsible for submitting the required documents with the correct information.

I'm sure you have many questions about the process including: signatures, notarization, payments, and photos. Read and follow the instructions online.

We don't have all the answers yet. Problems will come up and it will probably take several months to work them out.

Q: What's worse for you: sugar or artificial sweetener?

A: Americans consume a daily average of 22 teaspoons of sugar - that's about three times the recommended amount for most adults. You may think you are ahead of the game because you're not stirring it into coffee or sprinkling it on cereal, but think again: Sugar is in 80 percent of the products at the grocery store, including savory items like soup, beans and bread.

When artificial sweeteners came along, many of us thought, Great — they have no calories! But food isn't just calories. Different foods have different effects on our bodies. Artificial sweeteners are typically 200 to 600 times sweeter than sugar. They stimulate your taste buds, send signals to your brain, affect your hormones and slow your metabolism.

Both sugar and artificial sweeteners are potentially addictive, but artificial sweeteners may be likelier to make you get hungry, eat more throughout the day and develop diabetes. Sugar is OK in limited amounts and in the context of a healthy diet. Avoid highly processed store-bought foods and watch out for added sugar.

IMPORTANT INFORMATION ON MEDICARE PART B REIMBURSEMENTS

It has been brought to our attention by the City's Office of Labor Relations (OLR) that the Medicare Part B reimbursement amounts that will be issued to PBA Members during April 2018 may be less than what our Members paid in standard Medicare Part B premiums, excluding penalties. Therefore, you may be eligible for additional reimbursement.

This applies to individuals who fit at least one of the following criteria:

- Your 2017 monthly Medicare Part B premium was between \$110.00 and \$134.00.
- Your Medicare Part B, and/or your dependent's Medicare Part B, effective date is prior to 2016.
- You and/or your dependent did not receive Social Security benefits; therefore, you were billed directly for Medicare Part B Premiums.
- You were newly enrolled in Medicare Part B in 2017 and did not receive the higher reimbursement because you are a Line of Duty Survivor.

In the coming weeks, you will be receiving an important letter from the City regarding the Medicare Part B premium reimbursement discrepancy. By the time you receive the City's letter, you should have already received your Medicare Part B reimbursement, either through direct deposit to your bank account, or in the form of a check by mail. We urge you to follow the instructions which will be provided to you in the City's letter.

We will keep you apprised of any additional developments concerning this matter.

NYPD PISTOL CARRY PERMIT LIST OF PARTICULARS

You will receive a letter 2 to 4 weeks before your expiration date describing how to get onto NYPD application renewal web site to renew your carry permit. After your application is complete you will receive an e-mail of acceptance. Your renewed Pistol License will come to via USPS within 2 to 4 weeks later. Yes your license will have expired, but patrol force has been notified of the dilemma.


This letter will include:

- a) Your name
- b) Your status as retire
- c) Your pin. This is needed to continue returning to your personal renewal application.


You will need to copy and upload the following:

- 1) 2 Passport type photoes of yourself
- 2) Driver's License (obverse and reverse)
- 3) NYPD ID Card (obverse and reverse)
- 4) Current Pistol License (obverse and reverse)
- 5) Letter from spouse / significant other having "no objection to having a firearm in our house"
- 6) Request for "Public records exemption of publication"
- 7) Statement you are familiar with the Penal Law regarding falsified statements and about safeguarding a firearm.
- 8) Photoes of your safe with the open door and closed door if you have five or more firearms.
- 9) Birth Certificate
- 10) Social Security Number
- 11) DD 214 if applicable

The U.S. Postal Service went to the Aerial Fire Depot and Smokejumper Center in Missoula, MT on September 13 for the first-day-of-issue ceremony for a stamp that honors first responders.

“Our nation’s first responders rush into life-threatening situations for the benefit of others,” said Guy Cottrell, the Postal Inspection Service’s Chief Postal Inspector and dedicating official. “The Postal Service is pleased to honor their skill, dedication and unflinching bravery with this stamp.”

Artist Brian Stauffer worked with art director and designer Antonio Alcalá and designer Ricky Altizer to create this stamp. As a contributing artist to *The New York Times*, *Time* magazine, *The New Yorker* and other publications worldwide, Stauffer’s illustrations are best known for bridging traditional and digital realms to create a conceptual take on social issues.

10 Steps to Help Protect a Spouse

COUPLES CAN EASE THE BURDEN ON TOMORROW’S SURVIVOR BY DISCUSSING KEY FINANCIAL MATTERS TODAY. HERE ARE STEPS TO GET YOUR AFFAIRS IN ORDER

- 1. Gather financial papers.** Store deeds, passports, insurance policies, estate documents and the latest statements from financial accounts in a fireproof box at home, where survivors can easily find them.
- 2. Make a “must call” list.** Compile contact information for your accountant, lawyer and other financial professionals who need to be contacted when a spouse dies.
- 3. Share passwords.** Keep a master list of all usernames and passwords so your spouse can still have access after your death.
- 4. Update beneficiaries.** Make sure beneficiary designations for your pension, 401(k), IRA, brokerage accounts and life insurance proceeds still reflect your wishes.
- 5. Check credit cards.** Make sure your name is on the credit card account. In most states, when your spouse dies, you won’t be responsible for any debt on a card that’s not in your name. But you also won’t be able to use it, and will have to reapply for credit in your own name.
- 6. Set up advance directives.** You both will need health care powers of attorney to designate the person you want to make medical decisions on your behalf if you are incapacitated. You’ll also need a living will that spells out what measures you want the doctor to take to prolong your life.
- 7. Designate a money person.** Each of you will need a financial power of attorney so you can name a trusted person to make money decisions for you if you’re unable to do so.
- 8. Review wills and trusts.** Do this every few years or when there’s a significant change in your life, such as a sizable increase or decrease in your finances. If you don’t have a will, **get one.**
- 9. Discuss funeral plans.** This can save thousands of dollars by letting the surviving spouse—who may need the money—know it’s OK not to choose the most expensive funeral.
- 10. Learn how bills are paid.** Keep a list of how bills are paid so the survivor doesn’t miss a payment or overdraw an account.



SPONSOR
