Note 1: Fee does not apply if the Landscape Plan is received and approved before installation begins. If landscape installation is commenced before the Landscape Plan is received and approved, this \$1,000 Review Fee will apply.

Note 2: Applies to stakeouts and trash compliance inspections.

Note 3: ARC may reduce fee for minor modifications.

Note 4: Beginning with the fourth infraction of this rule, the fee will be \$5,000 and will result in the forfeiture of the entire Construction Deposit. A new \$10,000 Construction Deposit will be required before construction will be allowed to resume. In addition, if the ARC does not approve the unauthorized modification, the builder will be required to remove the unauthorized modification and return the home to the original Approved Building Plan at the builder's expense.

Note 5: This fee is required when the owner's septic tank will be connected to the community septic system. This is strictly a fee to connect to the community septic system.
