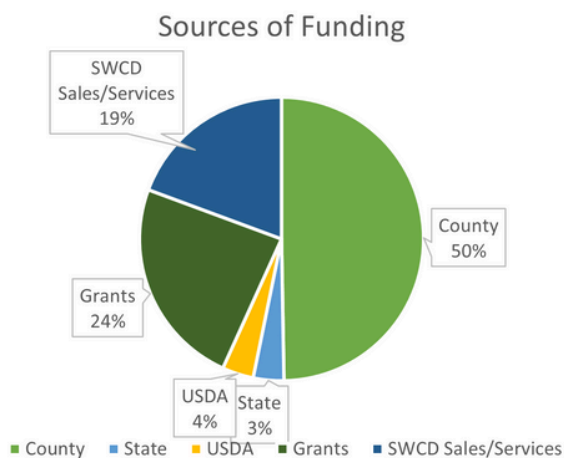

FINANCIAL OVERVIEW

The Tippecanoe Soil & Water Conservation District had an income of \$ 175,827.73 plus \$156,244.98 for 2 salaries and fringe benefits paid through the county and \$12,300 in-kind building space, utilities and supplies paid by NRCS. The total expenses of \$217,775.32 plus salaries and in-kind. Our net loss for 2023 was \$-41,947.59. This equaled out our net profit of \$40,080.43 in 2022.

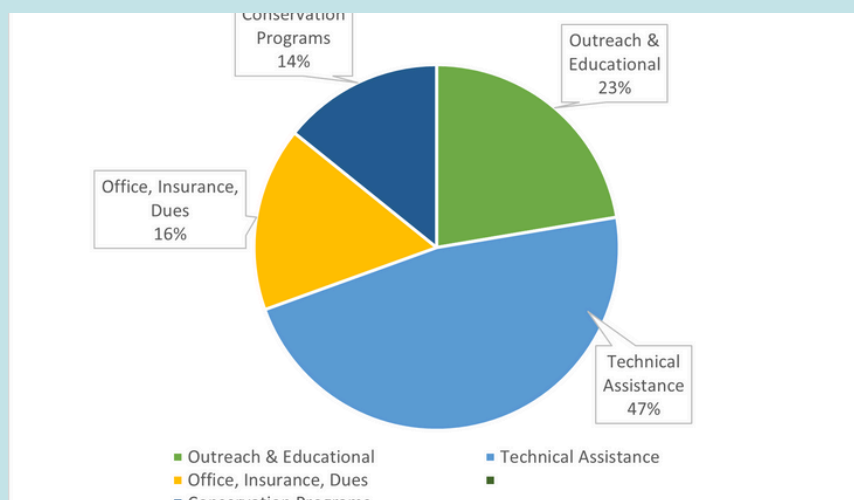
Sources of Funding

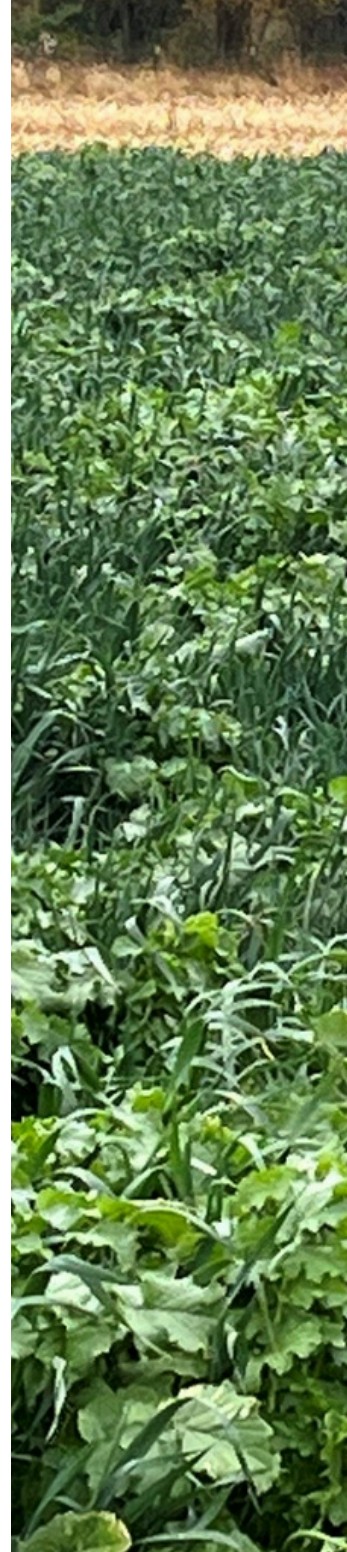

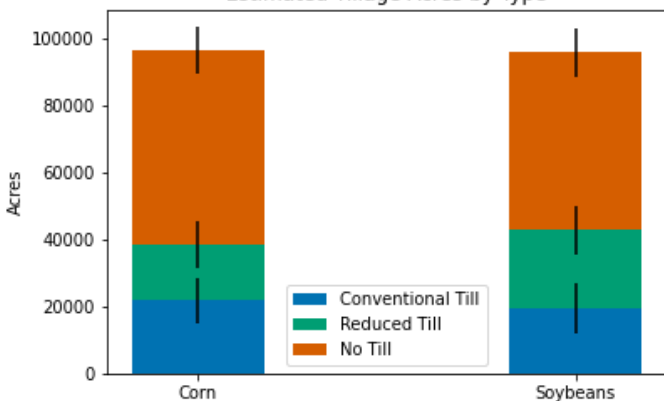

Estimated Tillage Acres by Type

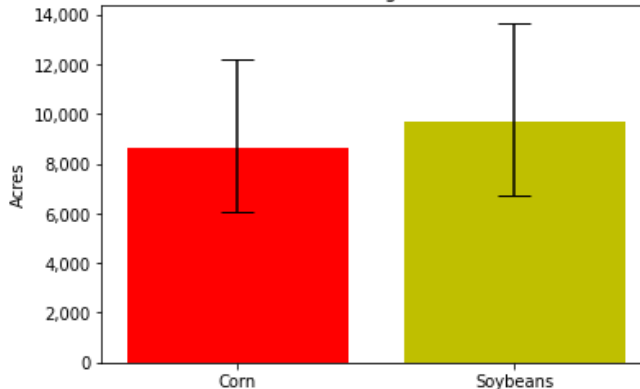

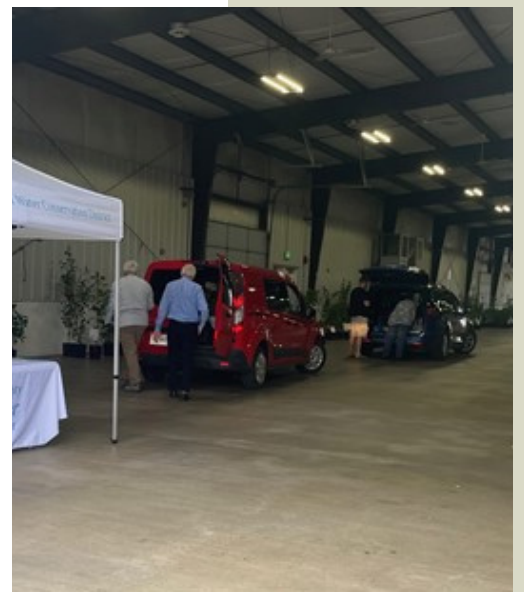
