
Reserving an item in MyTurn

1. Log in to your MyTurn account. If this is your first time using MyTurn, select "Create Account." When creating a new account, you will be required to enter a credit card number. We accept payment via cash, check, and card. The card associated with your account will be charged in the event of lost or damaged items.

2. Click "Inventory" in the upper left corner of the screen.



3. Click the blue "Reserve" button on the item you would like to rent.



4. In the window that opens, click the start and end dates for when you are reserving the item. Select the start date in the "From" calendar on the left, and the end date in the "To" calendar on the right. Reservation dates can be adjusted later to accommodate weather, etc.

After selecting dates, click the "Add Items" button if you would like to return to the tool library to reserve more items. Click the "Cart" button if you are ready to confirm the reservation.

Pick up of Conservation tools happens at 1812 Troxel Dr. Lafayette, IN 47909. Please check in at the office in the USDA building. We are open M-F 8:00 am through 4:30 P.M. Please call us at 765-474-9992 ext. 3 if you are coming from a distance to make sure someone is available to help you. Our office is closed for all Federal Holidays.

Click on the start and end dates for your reservation. When you're done selecting items, view your cart to confirm and submit your reservation. You can adjust quantities when viewing the cart.
