**Minutes of March 2, 2026**

The regular scheduled Trustee meeting called to order at 7:04 PM with the pledge of Allegiance. In attendance: Jed Lamb, Walter Rollin, Matt Combs, Nora Klebow, Amanda Jerore, Christine Novak and Carl Strekely.

**Motion** by Lamb with a second by Rollin to approve the meeting minutes of the February 16, 2026 meeting as written. Roll Call: two yeas.

**FINANCIAL REPORT:** Novak- February Revenue \$25,083.33. February Expenditures \$39,010.81. February Fund Balance \$595,397.96. **Motion** by Lamb with a second from Rollin to approve the Fiscal Report. Roll Call: two yeas

Novak presented a new time sheet form for the Township employees to use. Combs in agreement

Novak received Workman's Compensation-related mail from a different Huntington Township. Trustees suggested returning to sender. Novak to investigate further.

Novak received an email stating two PayPal transactions had come out of the account for bitcoin purchases, but the transactions were not noted on the bank statement. Trustees discussed the possibility of it being a phishing scam. Novak to monitor bank statements for fraudulent transactions.

Novak and the Trustees discussed the internet router going obsolete, Netgear will no longer service. Purchasing new router upgrade prices discussed. Decision to keep current router, since the Township has never had to have the router serviced.

**OPWC/SWAC-** Combs: Two bridges in Hawley Rd- 1 north and 1 south of 162 being rebuilt this year

**LCOOA-** Rollin: No new report.

**CEMETARY-** Rollin: No new report.

**ROADS-** Combs: Trustees asked what roads need done this year. Combs answered McMillan for sure, but waiting for weather to break to really look at what needs done.

**EQUIPMENT-** Combs: Everything going well. Back window was replaced in the backhoe

**RECYCLING-** Holmes: No new report.

**ZONING INSPECTOR-** Klebow: Presented spreadsheet dated March 2, 2026.

Brought up the subscription renewal for OTA webinars. Cost \$250 for the year for all Township personnel to access the webinars. **Motion** by Lamb with a second by Rollin to renew the subscription. Roll Call: 2 yeas

Zoning received a complaint at the ZBA meeting about a business operating without a license. Rollin added a complaint about a property where people seem to be living in a camper trailer with no septic system or occupancy permit. Klebow to investigate.

Rollin stated that Lynn brought to his attention that the Township has lawn maintenance fees in the zoning regulations. Klebow states she does not believe we do, but will look again through the zoning book.

**ZONING SECRETARY-** Jerore: ZBA had their organizational meeting last week. Approved 6 of the 9 current Conditional Use permits. Klebow has communicated with the remaining 3 and they should be sending in their applications soon.

Zoning decided to move ahead with discussions regarding the current Land Use Plan. Trustees recommended reaching out to Assistant Prosecuting Attorney Barbara Tamas as a resource and also agreed that they would approve additional meetings if requested.

**LCTA-** Meeting on March 19, 2026. Unsure of location.

**PREVIOUS BUSINESS-** LCTA meeting hosted by Huntington Township went well. Had about 60 attendees. Food received good reviews.

**NEW BUSINESS-** No new business.

**CORRESPONDENCE/ANNOUNCEMENTS-** There is currently a burning ban throughout Ohio.

Tickets are now available for the Memorial Parade chicken BBQ. The Township is only selling 100 tickets.
