Minutes of June 16, 2025

The Huntington Township Trustees met in regular scheduled meeting at 7:00 called to order with the pledge of Allegiance. In attendance: Jed Lamb, Robert Holmes, Walter Rollin, Matt Combs, Barbara Murray, Sheila Lanning, Brian Worcester and Connie Dombrowski. *Motion* by Holmes with a second by Rollin to approve the minutes of the June 2, 2025 regular scheduled meeting as amended. Roll call: three yeas. Checks 11038-11051 and payments totaling \$10,818.71 were approved for payment.

PUBLIC COMMENTS- Murray reported the Public Records Request notice is on the web site, Zoning Commission amendment for Cell Towers is being reviewed by the Lorain County Planning Commission and a Public Hearing will be scheduled when the review is complete. Connie Dombrowski thanked the Trustees for the chicken BBQ on 5/25/2025. Wreaths across America received \$500.00 from the BBQ, to cover 24 wreaths. December 13th the wreaths will be placed upon graves. Amvets will work to promote fund raising BBQ in 2026. Brian Worcester of Baker Road by New London Eastern Road asked Trustees to address a section of Baker Road where tar is surfacing. Combs replied that he would put some stone on the road tomorrow.

WATER- Lamb: Avon Lake increased rates to Rural Water 4% but it will not be passed along to consumers. Looking at using a rental car agency to manage the fleet.

LORCO- Lamb: unable to attend the meeting 6/12/2025.

AMBULANCE- Holmes: training 7/1/2025, board meeting 7/8/2025, got a new Squad.

FIRE- Rollin: Refurbish of vehicle should be done by 7/4/2025.

OPWC/SWAC- Combs: start ditching Clark Road soon.

CEMETERY- Rollin: ground work is almost done, plotting the sites will be next.

ROADS- Combs: Working with Ben at Rochester running black top next week with Stewart Road to be done first. Roadside mowing to start again.

EQUIPMENT- Combs: Red dump returned but Ford balked at transmission replacement. Harrison recommended running till repairs unavoidable.

RECYCLE- Rollin: How much received from Dumpster Day metal. \$652.00

ZONING- Rollin: still need to find Zoning Commission and Zoning Appeals Board members.

LCTA- Meeting this month is in Carlisle Township.

PREVIOUS BUSINESS- Rollin: Grant project of electrification of the park, Ferguson for underground boring and an electrician.

NEW BUSINESS- Holmes: Lorain County composting company: no use in the Township. Complaint about living conditions at Ukrainian Youth Camp caretaker's house. Don't believe this is the Township's responsibility. No one contacted me yet so I will call them tomorrow.
