Minutes of July 1, 2024

The Huntington Township Trustees met in special scheduled public hearing at 6:45 PM called to order with the pledge of Allegiance. Attendees: Walter Rollin, Jed Lamb, Robert Holmes, Matt Combs, Sheila Lanning. Additional arrivals prior to 7:00 PM: Lyn Ickes, Frances Rollin, Amber Frye, Todd Denes, Bruce Hager, Nora Klebow and Brenda Buchannan. The proposed 2025 Budget was presented, hearing no comments or questions the Public Hearing was adjourned on a *Motion* by Holmes with a second by Rollin at 6:50 PM. Roll call: three yeas.

The Huntington Township Trustees met in regular scheduled meeting on 7.1.2024 at 7:00 called to order with the pledge of Allegiance. *Motion* by Holmes with a second by Rollin to approve the minutes of the June 17, 2024 regular scheduled meeting as written. Roll call: three yeas. Checks 10704-10723 and payments totaling \$30,634.23 were approved for payment. *Motion* by Rollin with a second by Holmes to approve the June Financial reports showing \$277,698.75 year to date revenue, \$184,905.63 year to date expenditures and bank balances of \$680,467.60. Roll call: three yeas. *Motion* by Lamb with a second by Holmes to authorize *Resolution #2024-41* the 2025 Estimated Resources Budget as presented. Roll call: three yeas.

PUBLIC COMMENTS- Lyn Ickes: Bad news there will be zero dollars for the Huntington Safety Building from the State. Suggest bonding out the new building construction. Might get grants for misc. items like HVAC. Holmes: what did the Commissioners do with all that American Rescue Plan money. At the Township Association meeting Dave Moore said there was money left and the next day the newspaper article had all the money given to county departments. Lyn Ickes: you need to talk to Dave Moore, you should get an engineer drawing. July 18th is SWAC meeting in Penfield. Heard the new mini excavator was used for a culvert and need very well. Brenda Buchannan: Candidate running for State Representative, served public on school board and would like to take concerns to Columbus as new State Representative.

WATER- Lamb: meeting coming up, training on 10th

AMBULANCE- Holmes: training tomorrow, board meeting 7/9/2024

FIRE- Rollin- meeting Wednesday before fireworks display.

OPWC/SWAC- Combs: SWAC meeting coming up, culvert done on Hawley by the mini grant. The excavator was used and did very well.

CEMETERY- Rollin: possible burial Friday or Saturday, believe it to be for James Slater. Lanning: call from MaryAnn McMahon – Knorr asking for name change on deeds with name of Terrance McMahon (deceased first husband). Trustees in charge of rules of Cemetery in accordance with ORC, drafted a letter to MaryAnn that will be sent and attached to 2 deeds (318 & 319 West) if approved by Trustees. *Consensus* to approve the letter and send to MaryAnn clarifying rules of succession of deeds.

ROADS- Combs: culvert on Hawley installed but still needs black top over it, Hawley still needs patched, about 10 more loads of patch needed. ODOT called and asked if Township wanted Cemetery closed when they closed SR 58 for culvert repair to stop people from turning around in Cemetery. Told them yes. No start date on Melway Chip/Seal yet. Rollin: Melway won the County bid for Chip/Seal so it may affect our start date.

EQUIPMENT- Combs: new track hoe good, Lamb to get on insurance.

RECYCLE- Lanning: received \$541.00 and \$82.60 from Country View recycling for metal.

ZONING- Klebow reviewed report dated 7.1.2024 and is putting together information on shipping containers for the website.

LCTA- Holmes: tickets available for Fair breakfast, sign up to work the booth. Next meeting in Penfield.

EMPLOYEES- nothing
