Minutes of April 21, 2025

The Huntington Township Trustees met in regular scheduled meeting at 7:00 called to order with the pledge of Allegiance. In attendance: Jed Lamb, Robert Holmes, Walter Rollin, Matt Combs, Barbara Murray, Sheila Lanning, Alaina and Abel Combs. *Motion* by Holmes with a second by Rollin to approve the minutes of the April 7th 2025 regular scheduled meeting as amended to correct the date from April 8th 2025. Roll call: three yeas. Checks 10987- 10991 and payments totaling \$9,200.60 were approved for payment.

PUBLIC COMMENTS- Secretary Barbara Murray presented Wellington Cemetery draft policy on Indigent Burials and ORC policy example. Secretary Murray explained that Wellington was in the process of developing their policy and she would use that local example to develop Huntington's policy. Discussion on the subject of Indigent burials conclude with consent to table **Resolution 2025-9** until a policy is developed.
