Minutes of February 3, 2025

The Huntington Township Trustees met in regular scheduled meeting at 7:00 called to order with the pledge of Allegiance. In attendance: Jed Lamb, Robert Holmes, Walter Rollin, Matt Combs, Nora Klebow, Barbara Murray, Sheila Lanning, Bruce Hager, Lyn Ickes, Doloris O'Connor and Carl Strekley. *Motion* by Holmes with a second by Rollin to approve the minutes of the January 20, 2025 regular scheduled meeting as written. Roll call: three yeas. Checks 10909-10931 and payments totaling \$16,652.85 were approved for payment. *Motion* by Rollin with a second by Holmes to approve the January Financial reports showing \$21,863.91 year to date revenue, \$16,189.34 year to date expenditures and bank balances of \$527,572.89. Roll call: three yeas. *Motion* by Rollin with a second by Holmes to authorize *Resolution #2025-4* authorizing the MOU for 18 months of WENS service as proposed by Emergency Management. Roll call: three yeas.

PUBLIC COMMENTS- Lyn Ickes stated she had received word that a \$6,226.00 Grant from Ross Foundation Inc. has been awarded to the Township. The Grant purpose is installing electrical service at the Community Park. The Township must display the Ross Foundation name and/or Logo prominently and forward all mentions of the Ross Foundations Sponsorship to the Administrator of the Foundation. Ickes also discussed the 2024 SWAC grant request of \$8,100.00 for culvert work on Clark Road by the Moskal property. Ickes recommended the grant amount be decreased to \$7,500.00 full better funding opportunity in the category of a mini grant from SWAC. *Consensus* of Trustees to reduce the amount on the grant request to \$7,500.00.
