Minutes of July 15, 2024

The Huntington Township Trustees met in regular scheduled meeting on 7.15.2024 at 7:00 called to order with the pledge of Allegiance. In attendance: Matt Combs, Jed Lamb, Walter Rollin, Robert Holmes, Sheila Lanning, Lyn Ickes and Frances Rollin. *Motion* by Holmes with a second by Rollin to approve the minutes of the July 1, 2024 regular scheduled meeting as written. Roll call: three yeas. Checks 10724-10733 and payments totaling \$27,625.58 were approved for payment.

PUBLIC COMMENTS- Lyn Ickes: are the Trustees intending to use the ARPA money for Engineer drawings of a new Safety Service Building. Discussion on type of building either as design build or other. Holmes: talked to McConnell about cost of Pittsfield building. Might break the cost of the engineer into three \$50,000.00 increments. Ickes: can't do that, it is illegal. Lamb: need to keep on this.

WATER- Lamb: attended training on Put-N-Bay, learned about grant funding to train operators at the University of Toledo and AI uses in the utility industry. Meeting is this week. Holmes: are water meters changed. Lamb: all done.

ROADS- Combs: Melway got the County contract and might be able to chip / seal in the Township by end of July or early August. Need probably 8/10 more patching loads for roads. Rollin: enough stone for chip / seal purchased. Combs: yes, stone has been purchased.
