Minutes of June 2, 2025

The Huntington Township Trustees met in regular scheduled meeting at 7:00 called to order with the pledge of Allegiance. In attendance: Jed Lamb, Robert Holmes, Walter Rollin, Matt Combs, Nora Klebow, Barbara Murray, Sheila Lanning and Carl Strekely. *Motion* by Holmes with a second by Rollin to approve the minutes of the May 19, 2025 regular scheduled meeting as written. Roll call: three yeas. Checks 11015-11037 and payments totaling \$21,396.80 were approved for payment. *Motion* by Rollin with a second by Holmes to approve the May Financial reports showing \$314,211.75 year to date revenue, \$135,949.77 year to date expenditures and bank balances of \$700,160.30. Roll call: three yeas.

PUBLIC COMMENTS- Lamb stated the chicken BBQ on Sunday 5/25/2025 west well with about \$500.00 raised to donate to Wreaths across America. A letter showing the total will be available at the next Trustee meeting.
