Minutes of June 3, 2024

The Huntington Township Trustees met in regular scheduled meeting at 7:00 PM called to order with the pledge of Allegiance. Attendees: Walter Rollin, Jed Lamb, Matt Combs, Sheila Lanning, Lyn Ickes, Jennifer Post, David Post, Jonathan Post, Adam Mourton and Frances Rollin. *Motion* by Rollin with a second by Lamb to approve the minutes of the May 20, 2024 regular scheduled meeting as written. Roll call: three yeas. Checks 10675-10691 and payments totaling \$15,847.25 were approved for payment. *Motion* by Rollin with a second by Lamb to approve the May Financial reports showing \$254,492.00 year to date revenue, \$140,376.73 year to date expenditures and bank balances of \$701,789.75. Roll call: three yeas.

PUBLIC COMMENTS- Frances Rollin asked again about progress on fixing the roof. Historical Society items are getting damaged. Combs: again made several calls trying to get quotes. David Kelsey offered to work on roof repairs. Discussion included Lamb: safety concerns with someone on the roof that does not do roofing for a business. Lyn Ickes: it is a liability issue also. Frances Rollin: once fixed, the ceiling tiles will have to be replaced that were damaged.

David and Jonathan Post explained their attendance and the merit badge on communication they are working on getting for attending a public meeting. There are from the Wellington Boy Scouts.

Lyn Ickes informed the Board that at the Storm Water District Board meeting all Community grants were agreed to be funded. The Commissioners need to spend down the American Rescue Plan Act money. Discussion on the Rochester/Huntington application for a machine. Commissioners think the machine is too small and increased the grant to \$100,000.00. Need three quotes from State bid authorized sellers.- Adam Mourton- will get quotes for next size machine with Lamb and remit. Lyn Ickes: someone from each township should attend Storm Water meetings.
