Minutes of January 20, 2025

The Huntington Township Trustees met in regular scheduled meeting at 7:00 called to order with the pledge of Allegiance. In attendance was Jed Lamb, Walter Rollin, Robert Holmes, Matt Combs, Sheila Lanning and Barbara Murray. *Motion* by Holmes with a second by Rollin to approve the minutes of 1.6.2025 as written. Roll call: three yeas. Checks 10895-10908 and payments totaling \$10,652.38 were approved for payment.

Lanning: 2024 Annual financial report and 2025 Township roster completed. Certificate of Estimated Resources received.

PUBLIC COMMENTS- Welcome to Barbara Murray, the new Zoning Secretary. Holmes: meals on wheels does not come to Huntington anymore, completed the application for IRS TCC number.

COMMITTEE REPORTS:

WATER- Lamb: same officers elected to 2025 Board, Lanning to check on e-billing.

LORCO- Lamb: same officers elected to 2025 Board, County attended meeting to discuss forming a 6119 Board. Revenue will come from users only.

AMBULANCE- Holmes: Helipad approved for Brighton Township, Same officers elected to 2025 Board. December and year to date: Maintenance: \$637.21, \$14,251.74. Mileage: 4,188, 48,251.74. Runs: 146, 1661. Huntington runs: 5, 114.

FIRE- Rollin- same officers elected to 2025 Board.

CEMETERY- Rollin: Sold one lot and bought back one lot. Two single and 60 double lots left in West Cemetery. Flags at half-staff, signed up for notices on lowering and raising flag.

ROADS- Combs: busy taking care of roads.

EQUIPMENT- Combs: Looking into USDA Forestry Grant Opportunity for Boom mower. Safety kits ordered for trucks from Amazon.

RECYCLE- 4th quarter tonnage received.

ZONING- New Zoning Secretary is Barbara Murray. Holmes: Overstreet? Amendment Ferguson and email from Nora.

LCTA- Holmes: poor turn out, mostly politicians.

EMPLOYEES- Lanning: thoughts on raising credit card limit to 2,000 and getting cards for Zoning Secretary and Zoning Inspector. *Consensus* to only raise limit for Combs and Lanning, get cards for Zoning Secretary and Zoning Inspector. Lanning: decision on Trustee meeting only once a month, *Consensus* to keep two meetings a month and revisit.

NEW BUSINESS- Holmes: SAM renewal received, Lanning explained that System for Award Management is only needed when applying for Federal Grants and the solicitation is from a company that would RENEW the Township's SAM number for money. Holmes: BAS Boundary and Annexation Survey received. Email about moving website to .gov received.
