Minutes of July 7, 2025

The Huntington Township Trustees met in special scheduled Public Hearing at 6:45 PM called to order by Trustee Jed Lamb. In attendance: Jed Lamb, Robert Holmes, Walter Rollin, Matt Combs, Nora Klebow, Sheila Lanning, Carl Strekely, Chris Ferguson, Ernie Hartman, and Ted Yost. The proposed 2026 Budget was presented for review. Hearing no questions, the Hearing was closed on a *Motion* by Lamb with a second by Holmes at 6:49 PM with all voting in favor.

The July 7 Trustee meeting called to order at 7:00 PM with the pledge of Allegiance. *Motion* by Holmes with a second by Rollin to approve the minutes of the June 16, 2025 regular scheduled meeting as written. Roll call: three yeas. Checks 11052-11070 and payments totaling \$34,305.62 were approved for payment. *Motion* by Rollin with a second by Holmes to approve the June Financial reports showing \$339,422.14 year to date revenue, \$168,328.51 year to date expenditures and bank balances of \$692,991.95. Roll call: three yeas. *Motion* by Holmes with a second by Rollin to authorize *Resolution 2025-11* approving the 2026 Budget showing estimated revenue of \$688,506.71 and expenditures of \$602,504.26. Roll call: three yeas.

PUBLIC COMMENTS- Christopher Ferguson presented the invoice for the Cemetery expansion and also discussed the use of baseball fields by Black River Ball teams. Black River was told they need to fix the fields for play and work out a communication scheduling method. Ferguson will consider helping with the cost to improve the fields. Holmes- asked if Ferguson could get an estimate. Rollin- willing to put some money towards the fix. Lamb- bring your ideas and costs to us, if you want to be the primary contact for the park (pavilion and fields) let us know. Ernie Hartman- the corner of Griggs and SR 58 needs mowing for clear view of the intersection. Combs- will make calls on it tomorrow. Rollin- complaint of overgrowth at Baker and SR 162 also. Ernie Hartman- what is the price of culvert pipe and cover like recently done at Broud's. Combs-\$140.00 per 20' of pipe. Hartman- and what about the work, Combs- the way we do it since I have been here is, we get the pipe, I get your approval and you pay for the bill, I don't have dirt. We buy pipe and I send you a bill, I don't have any dirt you will want in your yard. Hartman- I am thinking of running from edge of my driveway. Holmes- call the county for ditch dirt. Rollin- maybe TJ Denes has dirt.

COMMITTEE REPORTS:

WATER- Lamb: meeting 7/9/2025, attending the annual national meeting in New Orleans in September and unable to attend the Trustee meeting 9/15/2025.

LORCO- Lamb: meeting this week.

AMBULANCE- Holmes: board meeting 7/8/2025.

FIRE- Rollin: meeting last Wednesday, truck getting refurbished and should be done by September, new truck should be in service by middle of August.

OPWC/SWAC- Combs: making calls tomorrow, would like to do Stewart by county line or McMillan by Herdies.

CEMETERY- Rollin: Thank you to Ferg's Construction for good job on cemetery. Holding water on one side, road is a little weavey. Lamb: look into Cemetery Grant Program information.

ROADS- Combs: Gave pipe inventory to Sheila, 1 10" left. Running blacktop this week.

EQUIPMENT- Combs: calling Ohio elevator and Mosely tomorrow, truck transmission is still acting up, roller needed a new solenoid, road grader needed new hydraulic lines.

ZONING- Klebow: Getting Mr. Yost his signed permit from the ZBA meeting. Presented a spreadsheet of zoning activities dated 7.7.2025. Rollin- new septic has been installed at SR 162 & West Road property. Klebow: the neighbor to the south has issues, appears to not have completed sanitary sewer, water goes into the property but not out. Combs: Paul Miller on Hawley Road need a shed permit & Wacker residence 47475
