### Minutes of May 20, 2024

The Huntington Township Trustees met in regular scheduled meeting at 7:00 PM called to order with the pledge of Allegiance. Attendees: Robert Holmes, Walter Rollin, Jed Lamb, Matt Combs and Frances Rollin. *Motion* by Holmes with a second by Rollin to approve the minutes of the May 6, 2024 regular scheduled meeting as written. Roll call: three yeas. Checks 10670-10674 and payments totaling \$10,502.89 were approved for payment

**PUBLIC COMMENTS-** Frances Rollin asked about progress on fixing the roof. Combs: made several calls and no one returned the calls. Frances Rollin has a name that she will provide.

**WATER-** Lamb: nothing to report **LORCO-** Lamb: nothing to report

**AMBULANCE-** Holmes: April Huntington runs 8, district total 108, year to date district 489. April mileage 3600, year to date 16,796. Maintenance cost April \$3,781.68 year to date \$11,822.88. Starting June 1<sup>st</sup> Huntington satellite station will not be scheduled due to statistics. Crews will still be scheduled out of Wellington, due to response times and calls. Ambulance will still be here and maintained weekly. If needed there are enough emergency medical technicians that live south of the tracks in Wellington that can respond, statistics will be reviewed quarterly and approved by the Board. If there is funding to build something here they will return. The conditions in the lower level are not good for living. The crews from Wellington were out here in 1 minute after the Huntington crews arrived.

**FIRE-** Rollin- looking at purchasing another truck.

**OPWC/SWAC-** Combs: getting pipe in the ground soon. Lamb: when there are meetings we need to be there, we need a representative.

**CEMETERY-** Rollin: meeting with Doug Hastings tomorrow on veterans in there and he has new flags coming for us. Picking up wreaths and wagon Friday. Combs: mowing this week so no trimming around Doug Hastings flags. Footers poured and veterans headstone installed.

**ROADS-** Combs: mowing sides, blacktop in couple weeks.

**SAFETY SERVICE BUILDING-** Holmes: holding

**EQUIPMENT-** Combs: all in good shape

**RECYCLE-** Holmes: dumpster days went well, thank you to everyone.

**ZONING-** Klebow: provided a review of zoning issues dated 5.21.2024. County training 5.29.2024.

**LCTA-** Holmes: Auditor Craig Snodgrass guest speaker, reappraisals up 25%-31%, letters will be sent to residents. Frances Rollin: are they having a guy come around surveying, I had a guy on my property surveying. Lamb: not surveying but appraising, looking at everything. Tell that guy to come back with a paper or something. Rollin: would it be a survey for the water line.
