Minutes of April 8, 2025

The Huntington Township Trustees met in regular scheduled meeting at 7:00 called to order with the pledge of Allegiance. In attendance: Jed Lamb, Robert Holmes, Walter Rollin, Matt Combs, Nora Klebow, Barbara Murray, Sheila Lanning, Fire Chief Mike Wetherbee, Ted Yost, Jennifer Pierce, Austin Pierce, Brian Cooney, Chris Ferguson, and Carl Strekley. *Motion* by Rollin with a second by Holmes to approve the minutes of the March 17, 2025 regular scheduled meeting as written. Roll call: three yeas. Checks 10967- 10986 and payments totaling \$30,582.74 were approved for payment. *Motion* by Holmes with a second by Rollin to approve the March Financial reports showing \$250,768.58 year to date revenue, \$76,229.77 year to date expenditures and bank balances of \$696,437.13. Roll call: three yeas. *Motion* by Holmes with a second by Rollin to authorize *Resolution #2025-8* authorizing participation in the ODOT annual salt bid in accordance with ORC 5513.01(B). Roll call: three yeas.

PUBLIC COMMENTS- Carl Strekely asked about Spring dumpster days, Rollin stated May 16th & 17th and will coincide with Lorain County Beautiful. Trustees discussed the details of dumpster days activities. Christopher Ferguson inquired about use of the ball fields by Black River baseball. Discussion on field preparation and contact in the Township for field reservation is Robert Bort at 440-647-5100. Combs indicated that resident McConnell also worked with Robert Bort on field reservations. Ted Yost introduced himself and inquired of local compliance for making fancy rifle and pistol stocks. Nora Klebow pointed Yost to zoning requirements and her contact information.

AMBULANCE- Holmes: training 4/1/2025, board meeting 4/8/2025. Audit of 2022 & 2023 received.

FIRE- Fire Chief Wetherbee attended to thank the Trustees for supporting upcoming ballot issue. Discussion on the recent fire at a home on West Road. Rollin: thank you to the Fire Chief for handling of the fire on West Road.

SHERIFF- Received January and February reports of incidents in Huntington Township. Holmes: there is a Warden Program developing for anyone interested.

OPWC/SWAC- Combs: have not heard on Clark Road Grant

CEMETERY- Rollin: don't have the quotes for Cemetery expansion yet. Did not need to address the indigent burial recently sent by Lorain County Coroner. Lamb: Discussed with other Townships and we should have a policy per ORC 9.15.

ROADS- Combs: culvert on Clark Road is complete, request on Baker Road for ditch cleaning. Looking at chip and seal of McMillian and Stewart Roads.

EQUIPMENT- Lamb: Gradall owned by Wellington, Rochester and Huntington Township has been discussed with other Townships. *Motion* by Holmes with a second by Rollin to authorize the disposal of the Gradall owned by Wellington, Rochester and Huntington Townships at the discretion of Matt Combs. Roll call: three yeas. Rollin: would hate to see it scrapped, would like to find someone interested in repairing. Lamb: want the most economical way to dispose of it.

RECYCLE- Holmes: shredding is free for the Townships, Farm Tire collection is 9/25/2025, Keep Lorain County Beautiful Cleanup Day is May 17th 2025, Lorain County collection center information put on Facebook.

ZONING- Klebow: presented report dated 4.7.2025, Zoning Board of Appeals got through 3 conditional applications at meeting of 3.24.2025. The Kozik's brought in more cars and will be escalated to the Prosecutor. The Zoning Commission Board will now work on building versus non buildable lots within the
