The Huntington Township Trustees met in regular scheduled meeting at 7:00 called to order with the pledge of Allegiance. Roll call: three yeas. Checks 10932-10943 and payments totaling \$14,154.68 were approved for payment. *Motion* by Rollin with a second by Holmes to approve *Resolution 2025-5* authorizing amendments to appropriations by increasing \$215,729.68. Roll call: three yeas.
