## Minutes of May 6, 2024

The Huntington Township Trustees met in regular scheduled meeting at 7:00 PM called to order with the pledge of Allegiance. Attendees: Robert Holmes, Walter Rollin, Jed Lamb, Sheila Lanning, Matt Combs, Nora Klebow, Frances Rollin, Fire Chief Mike Wetherbee, Carl Strekely and Layne Lawhon. *Motion* by Holmes with a second by Rollin to approve the minutes of the April 15, 2024 regular scheduled meeting as written. Roll call: three yeas. Checks 10653-10669 and payments totaling \$10,796.52 were approved for payment. *Motion* by Rollin with a second by Holmes to approve the April Financial Reports with year to date revenue of \$230,972.85, expenditures \$119,077.32 and bank balances of \$699,570.01. Roll call: three yeas.

WATER- Lamb: meeting upcoming

**FIRE-** Rollin- meeting upcoming, Fire Chief Wetherbee: Went over the Wellington Fire District 2023 Recap that was passed out. Talked about the 2024 Eclipse and costs. The Eclipse was uneventful and the district is applying for reimbursement for expenses. Other recent expense reimbursement requests include the recent Columbia Gas leak smell that caused many 911 calls and responses.
