# Minutes of September 3, 2024

The Huntington Township Trustees met in special scheduled meeting at 7:00 PM called to order with the pledge of Allegiance. Attendees: Walter Rollin, Jed Lamb, Matt Combs, Robert Holmes, Nora Klebow, Sheila Lanning, Lyn Ickes, Carl Strekely, Colleen Dull and Frances Rollin. *Motion* by Holmes with a second by Rollin to approve the minutes of the August 5, 2024 regular scheduled meeting as written. Roll call: three yeas. Checks 10755-10778 and payments totaling \$104,755.08 were approved for payment. *Motion* by Rollin with a second by Holmes to approve the August Financial reports showing \$449,306.69 year to date revenue, \$348,969.87 year to date expenditures and bank balances of \$688,082.19. Roll call: three yeas.

**PUBLIC COMMENTS-** Lyn Ickes reiterated to Trustees the date for the Harvest walk of October 19<sup>th</sup> 1:00-3:00 PM and asked why the Historical Society was not involved. Discussed reasoning and ways to contact Society.

### **COMMITTEE REPORTS:**

**WATER-** Lamb: attending training in Savannah Georgia. **LORCO-** Lamb: meeting 9/12/2024 and unable to attend. **AMBULANCE-** Holmes: Board meeting 9/10/2024.

**FIRE-** Rollin- tomorrow is meeting.

SHERIFF- Combs: call from Sheriff about a tree down.

**OPWC/SWAC-** Combs: seeing if we can get a project on Bursley Road. The big project done on Stewart Road. Discussion on culvert with silt buildup, Lyn Ickes suggested trying to get a mini grant.

**CEMETERY-** Lanning: call from Tracey Denig asking if open and close costs can be prepaid. *Consensus* to not allow prepaying at the local level but suggest to Ms. Denig to ask the funeral home if she is prepaying with them.

**ROADS-** Combs: Started road side mowing, might need a few more loads of patching. Still some shimming to be done.

**SAFETY SERVICE BUILDING-** Holmes: sent draftsman copies of what we have. Lanning: contacted Jim Miller at Lorain County port authority. Bonding \$750,000.00 for 20 to 25 years, current interest rate %4.9, estimated pay back between \$40,000.00 to 45,000.00 a year. Anything below one million costs \$80,000.00 to \$90,000.00 in underwriting fees and additional amounts in administrative fees. American Rescue Plan money expended: \$55,872.50, with \$86,211.16 left to commit or expend.

**ZONING-** Klebow presented the status of zoning spreadsheet dated 9/3/2024. Klebow: no application received yet from Overstreet on Western Reserve Land Conversancy. Holmes: talked with Overstreet about the proposed property purchase on Griggs Road on three occasions. Rollin: got call about shooting of AR15, should call Sheriff because not in Zoning per Lorain County Prosecutor office.

LCTA- Holmes: good turnout at the Fair.

**EMPLOYEES-** Combs: Layne has left.

**PREVIOUS BUSINESS-** Holmes: the roof replacement is complete.

**NEW BUSINESS-** Holmes: asked Frances if the County Fair was ever held in Huntington Township. Frances Rollin: yes, Ernest Hartman has a ticket from that first Fair.
