Minutes of December 2, 2024

The Huntington Township Trustees met in special scheduled public hearing at 6:45 PM called to order with the pledge of Allegiance. Attendees: Walter Rollin, Jed Lamb, Robert Holmes, Matt Combs, Sheila Lanning, Nora Klebow, Bruce Hager, Carl Strekely, Connie Dombrowski, Farrah Emeka and an agent from Whitaker-Myer. The proposed zoning amendment recommended by the Zoning Commission was presented, Chairman Lamb read aloud the Lorain County Planning Commission recommendation. Christopher Ferguson is requesting a change in Zoning from RA to B1 for a section of property on SR 162. Hearing no comments or questions the Public Hearing was adjourned on a *Motion* by Lamb with a second by Holmes at 6:50 PM. Roll call: three yeas.

The Huntington Township Trustees met in regular scheduled meeting at 7:00 called to order with the pledge of Allegiance. *Motion* by Holmes with a second by Rollin to approve the minutes of the November 18, 2024 regular scheduled meeting as written. Roll call: three yeas. Checks 10835-10854 and payments totaling \$41,962.49 were approved for payment. *Motion* by Rollin with a second by Holmes to approve the November Financial reports showing \$517,810.46 year to date revenue, \$519,981.90 year to date expenditures and bank balances of \$585,573.93. Roll call: three yeas. *Motion* by Lamb with a second by Rollin to authorize *Resolution #2024-49* approving the zoning amendment for Christopher Ferguson of property on SR 162 from RA to B1 as presented. Roll call: three yeas.

PUBLIC COMMENTS- Whitaker-Myers Agent: presented the insurance renewal with a slight increase and some changes of equipment added and taken off. The property values were increased and the historical building (one room school house) will be moved to Historical value instead of blanket coverage. *Motion* by Lamb with a second by Holmes to authorize and approve the insurance renewal with Whitaker-Myers as presented. Roll call: three yeas.

Farrah Emeka introduced herself and informed the audience that she is running for Oberlin Municipal Judge to replace retiring Judge Januzzi in 2025.
