Minutes of October 7, 2024

The Huntington Township Trustees met in regular scheduled meeting at 7:00 PM called to order with the pledge of Allegiance. Attendees: Walter Rollin, Jed Lamb, Matt Combs, Robert Holmes, Nora Klebow, Sheila Lanning, Lyn Ickes, Colleen Dull and Frances Rollin. *Motion* by Rollin with a second by Holmes to approve the minutes of the September 16th, 2024 special scheduled meeting as written. Roll call: three yeas. *Motion* by Holmes with a second by Rollin to approve the minutes of September 26, 2024 regular scheduled meeting as written. Roll call: three yeas. Checks 10788-10806 and payments totaling \$29,567.42 were approved for payment. *Motion* by Holmes with a second by Rollin to approve the September Financial reports showing \$474,174.99 year to date revenue, \$458,910.93 year to date expenditures and bank balances of \$603,009.43. Roll call: three yeas. *Motion* by Holmes with a second by Rolling to authorize *Resolution 2024-44* accepting the amounts and rates as presented by the Lorain County Budget Commission. Roll call: three yeas.

PUBLIC COMMENTS- Lyn Ickes: toured McMillan Road ditch today, there are questions on easements and deeds. Discussion on how to improve the ditch. Asked Trustees to determine how they want it handled as well as any work on the pond dipping. There is a possible grant available to provide electric to the concession building in the Park. *Motion* by Holmes with a second by Rollin to authorize Lyn Ickes to pursue the grant for the Township. Roll call: three yeas. There are a few people wanting to donate toward the Harvest Walk. Discussion on best method to accept donations.

WATER- Lamb: meeting Wednesday. Rollin: saw them servicing hydrants today.

LORCO- Lamb: meeting Thursday.

AMBULANCE- Holmes: meeting tomorrow.

FIRE- Rollin- Looking at purchasing \$850,000.00 pre-built truck.

CEMETERY- Rollin: Cremation for Beverly Roice Saturday.

ROADS- Combs: in good shape, might do a few more loads of patching. Will start road side cutting, a tree fell across Stewart road and was cut up.

SAFETY SERVICE BUILDING- Holmes: sent questions to Greg Peltz and waiting for answer. Lanning: Wellington Township did not get loans to put up their building.

EQUIPMENT- New truck running well, 2 quotes for light bars. *Motion* by Lamb with a second by Holmes to accept the bid from Hall Public Safety Upfitters for \$3.102.87 and use ARPA money to purchase lightbar. Roll call: three yeas. *Motion* by Lamb with a second by Holmes to authorize Matt Combs to sell the old truck using his discretion for appropriate time and asking price. Roll call: three yeas.

RECYCLE- Third quarter tonnage 19.42.

ZONING- Klebow presented the status of zoning spreadsheet dated 10/7/2024. Rollin: someone living in 5th wheel trailer on SR 58. Lamb: Mr. Ferguson called asking about his new building and commercial property. Klebow: Ferguson putting up barn as agricultural, discussion on ways for Mr. Ferguson to either apply to change the zoning or apply for zoning variance.
