## Minutes of September 16, 2024

The Huntington Township Trustees met in regular scheduled meeting at 7:00 PM called to order with the pledge of Allegiance. Attendees: Walter Rollin, Jed Lamb, Matt Combs, Robert Holmes, Sheila Lanning, Tony Cillo, Shelli Pluta, Micayla Pluta, Sheila Holmes, Linda Heyde, Ken Heyde, Giovanna Scaletta-Bremke, Hack Hall, Dolly Lee, Bob Lee and Frances Rollin. *Motion* by Rollin with a second by Holmes to approve the minutes of the September 3, 2024 special scheduled meeting as written. Roll call: three yeas. Checks 10779-10786 and payments totaling \$14,854.50 were approved for payment. *Motion* by Holmes with a second by Rollin to authorize *Resolution 2024-42* an MOU between Huntington and Rochester Townships for the purpose of defining proper care, custody and control of the shared cost of operation of an excavator. Roll call: three yeas.

**PUBLIC COMMENTS-** Tony Cillo Republican candidate for Lorain County Prosecutor, Giovanna Scaletta-Bremke Republican candidate for Lorain County Common Pleas Judge and Jack Hall Republican candidate for Lorain County Sheriff presented themselves and their positions.

**WATER-** Lamb: attended training in Savannah Georgia, good sessions were held. Meeting Wednesday.

LORCO- Lamb: unable to attend meeting.

**AMBULANCE-** Holmes: August mileage 4,840, year to date 33,322. Maintenance August \$367.03, year to date \$13,282.39. Runs August 149, year to date 1031. 1 overdose and no DOA. Huntington: 12 runs.

**FIRE-** Rollin- looking to purchase another vehicle, 2024 cost estimated at \$850,000.00 and 2025 cost estimated at over 1 million.

**OPWC/SWAC-** Combs: looking into doing McMillan ditch.

**OFFICE ON AGING-** Rollin: Ice cream social is the 19<sup>th</sup>.

**CEMETERY-** Lanning: found documents in old records for 1978 full burial of an infant on lot 432 East. Nothing noted in current records of this burial. Coincidently the baby's Uncle met to discuss concrete dumped near this lot. Discussion led to discovery of where baby is "believed" to be interred. Asking for motion to not allow any further burials on lot 432 due to unknown location of baby remains. *Motion* by Holmes with a second by Rollin to not allow any further burials on lot 432 East and to convey this verbally to current surviving family members. Roll call: 3 yeas.

**SAFETY SERVICE BUILDING-** Lanning: Pittsfield contacted about their new garage, they paid with funds willed (estate). Building finished with yearly budgeted amounts. Holmes: talked with draftsman and some figures coming this week or next meeting.

**ZONING-** Lanning: no quorum at August Zoning Commission meeting, need people on Zoning Board of Appeals and Zoning Commission Board. Any help with records review according to retention commission would be appreciated.
