Minutes of August 3, 2026

The regular scheduled Trustee meeting called to order at 7:00 PM with the pledge of Allegiance. In attendance: Robert Holmes, Jed Lamb, Walter Rollin, Matt Combs, Christine Novak, Nora Klebow, Amanda Jerore, Carl Strekely, Connie Dombrowsky, and Lyn Ickes.

Motion by Holmes with a second by Lamb to approve the meeting minutes of the July 20, 2026 meeting as written. Roll Call: three yeas.

PUBLIC COMMENT: Jack Pettry emailed the Township with a complaint regarding Rumpke. Holmes asked to be forwarded the email so he can respond personally.

Novak received a complaint from a resident regarding the dumpsters overflowing. Holmes spoke with Joe from Rumpke, who had been on vacation and did not have cover for his route. The dumpsters have since been emptied.

Lyn received information over the weekend that the USDA does not go by Township median income, but by County median income. The Lorain County median income is \$24,000.00 less than the Township median income. Meaning the Township could be eligible for the low/moderate income bracket for grant and loan options.

The Trustees presented Connie with a check written for \$1,025.00 to Wreaths Across America. These funds came from the Memorial Day BBQ. The Trustees thanked everyone who contributed and participated for making it possible. Wreaths Across America plans to be at the Huntington Township cemetery on December 19, 2026 at 10:00 AM and is hoping for better weather this year than last.

RURAL WATER- Lamb: Meeting coming up.

LORCO- Lamb: Meeting coming up.

AMBULANCE-Holmes: No meeting on August 4, 2026 due to National Night Out. Next board meeting scheduled for August 11, 2026.

FIRE- Rollin: Will be present at National Night Out at Wellington Rec Park on August 4, 2026 from 5:00 – 8:00 PM.

SHERIFF- no new report

OPWC/SWAC- Combs: No new report.

LCOOA- Rollin: No new report.

CEMETARY- Rollin: Check was written to purchase pins. Now waiting for markers to get shipped so Lewis Land can begin installation.

ROADS- Combs: Currently running blacktop and getting Rochester finished. Needs to run six more loads to finish Huntington Township. Roads are prepped and ready for work to be done. Roller is working well.

EQUIPMENT- Combs: Had a break malfunction in the freightliner. Took in to get break chambers fixed and greased. Combs could have done it himself, but with all the roadwork needing done and taking priority, he had to take it to a third party. Will have it back tomorrow.

RECYCLING- Holmes: No new report.

ZONING INSPECTOR- Klebow: Presented a spreadsheet dated August 3, 2026.

ZONING SECRETARY- Jerore: Zoning got a good start on changes and clean-up items in the Blue Book. Currently going through Lyn Icke's recommendations by item; rewording and moving things around so they flow and read better.

LCTA- No meeting in August due to the Lorain County Fair. Sign ups still available to work the fair booths. Tickets still available for the Breakfast on August 24, 2026, cost \$15.00.

PREVIOUS BUSINESS- Updates for Lorain County's collection day and Huntington Township's recycling program were posted to Facebook.

NEW BUSINESS- Lyn asked about the NIMS (National Incident Management System) certification and if it is still in effect. Lyn questioned if the Sheriff is aware of who has the certification and who to call in the case of an incident. She lives right next to the railroad tracks and asks about a plan if something were to happen. For example; where to go and who to call. Holmes stated that he believes the Sheriff would call the Trustees in the case of an incident to find out who, in the area, has a NIMS certification. Rollin discussed that Huntington Township has also opted in to Lorain County Emergency Response and they would be called in for situations that are too big for the Township to handle itself. Novak stated she would look into the NIMS certification at the Township level and report back.

CORRESPONDENCE/ANNOUNCEMENTS- There will be no second Trustee meeting in August and the first meeting of September will be on Tuesday the 8th due to Labor Day.

Motion by Holmes with a second by Lamb to adjourn. Roll Call: 3 yeas. Meeting adjourned 7:41 PM.
