## Minutes of July 21, 2025

The meeting called to order at 7:00 PM with the pledge of Allegiance. *Motion* by Holmes with a second by Rollin to approve the minutes of the July 7, 2025 regular scheduled meeting and Budget Public Hearing as written. Roll call: three yeas. Checks 11071-11078 and payments totaling \$86,739.69 were approved for payment.

**PUBLIC COMMENTS-** Holmes presented the returned items from resigned Zoning Secretary Barbara Murray and the following is taken from the taped recording within the meeting: Holmes: Barb asked me to return all this stuff and she wanted me to make sure it got up here to this. Matt in here there's a key in here, you gave her a key. Combs: yep. Holmes: This is her letter of resignation, she has some stamps, couple folders, the lap top and the printer. Lanning: when you say charge card, I need her credit card. Lamb: is that her credit card. Holmes: (undescernable) Sheila. Lanning: well your going to put it all downstairs in the office so if the credit card is in there I will call and cancel it. Holmes: I will take it downstairs. Lanning: I will put the rest in her file folder because Auditors check that. Holmes: while we are on that subject, John Pipcak, I called him and he is going to send me a letter of resignation. Lanning: thank you. Combs: any idea why she resigned when she was doing a good job in everything she was asked to do. Holmes: yes I do, well problem was and she sent this to Sheila, through today's political landscape um has no abuse has no place in rural politics especially when something is said off the record. I asked you on three different occasions to stop no menus no across any spectrum regards Barb. Holmes: Basically what she was saying was you, Lanning: (um hum) Holmes: had gone ahead on Jeff Jones. Lanning: I filed a complaint. Holmes: and she was, she, this was about the same time that couple up in (Combs: Minnesota) Minnesota got killed cause why, cause some crazy guy and she was afraid of Jeff Jones. You answer back: sorry, just home from Kipton Council meeting. Don't worry I did the reporting and your name or address was never mentioned. Fyi: I loved (you meant lived) in Tom & Krysh house for 22 years, bought the land from Jeff jones and I am very familiar with him. You are not tied in any way to this complaint, but my personal opinion is that you should stand up for your rights. Never fear, you will never enter any conversation. **CEMETERY-** Rollin: Sold 2 lots, the low are is repaired.

**ROADS-** Combs: At 20 loads so far of blacktop just on Stewart Road.

**EQUIPMENT-** Combs: Truck transmission finally went out; it is at Harrison Ford but if they can't get it in the shop soon it will go to Mike Bass Ford for the repair. Road roller engine blew up, rented one that we will split with Rochester for \$1,850.00 for a month. Lanning: has the other Gradall been scrapped yet. Combs & Lamb: not yet.
