Minutes of May 19, 2025

The Huntington Township Trustees met in regular scheduled meeting at 7:00 called to order with the pledge of Allegiance. In attendance: Jed Lamb, Robert Holmes, Walter Rollin (arrived at 7:17 PM), Matt Combs, Barbara Murray and Sheila Lanning. *Motion* by Holmes with a second by Lamb to approve the minutes of the May 5, 2025 regular scheduled meeting as written. Roll call: two yeas. Checks 11006-11014 and payments totaling \$6,645.63 were approved for payment. *Motion* by Lamb with a second by Holmes to authorize *Resolution #2025-11* entering into an MOU with Lorain County Storm Water for Moskal ditch mini grant in the amount of \$7,493.00. Roll call: two yeas.

PUBLIC COMMENTS- BBQ dinner 5/25/2025 at 12:30/1:00 PM. Murray: what is expected to be done with the Cemetery Data on the flash drive. Lamb: update the information, Lanning: the cemetery data was maintained till December 2024 and then turned over to Rollin.
