Financial Obligation Acknowledgement

- Students will be assessed a \$35 registration fee one-time yearly. Siblings may register at a reduced rate. Registration fees may be waived due to a scholarship or costume returned via our costume return program.
- Tuition is posted on the first of each month. Cash or check payments may be made at the front desk between the 1st and the 14th of each month. All remaining balances will be charged to the card on file on the 15th of the month. I agree to inform the front desk of any changes to my financial information prior to the 15th of the month.
- Failure to pay tuition by the 15th, is subject to a \$10 fee per week.
- Tuition is based on 9 calendar months. Some months have 5 weeks, others 4. As well, we are out for major holidays and spring break. We do not prorate for holidays or absences. Students may make up absences by scheduling through Jackrabbit. As well, the studio will hold 2 set general make-up dates for bad weather closing, etc. As a parent/guardian, you understand you are signing a nine-month contract, and you are responsible for all fees billed as they are split over time instead of billed individually.
- Students participating in the Winter Showcase will be assessed a \$40 performance fee in October. Additional students/classes will have \$25 per class costume rental fee. This will be automatically billed with tuition on October 15.
- Students participating in the spring ballet or recital may either select a recital package to be paid monthly or will be billed a deposit of \$25/costume in December to be automatically deducted on December 15. The remaining costume balances will be split between January and February and will be automatically deducted on the 15th of each month.
- Turning Pointe Dance Academy has a NO REFUND policy for all items purchased, registration fees, tuition paid, and team fee installment payments associated with your contract.
