1. B.A., Tamil
2. B.Com.
3. B.Sc., Zoology
4. B.Sc., Artificial Intelligence and Machine Learning
5. B.Sc., Computer Science

With reference to the above G.O. First cited and your proposal second cited for grant of provisional affiliation for establishing a new self - financing Arts and Science College in the name and style of **“Brilliant College of Arts and Science for Women”, No. 3/87 A, Thiruvarur Road, Paruthichery Village, Velur Post, Thiruthuraipoondi Tk., Thiruvarur - 614 715**” with **Five (05) U.G. programmes**, an Inspection Commission was appointed in the reference third cited. The Inspection Commission inspected the site at **No. 3/87 A, Thiruvarur Road, Paruthichery Village, Velur Post, Thiruthuraipoondi Tk., Thiruvarur - 614 715** on **05.08.2025** and submitted its reports.

I am, by direction, to inform that the reports of the Inspection Commission were considered by the University and it has been decided that the provisional affiliation be granted for establishment of new self - financing Arts and Science College in the name and style of **“Brilliant College of Arts and Science for Women”, No. 3/87 A, Thiruvarur Road, Paruthichery Village, Velur Post, Thiruthuraipoondi Tk., Thiruvarur - 614 715**” and to offer the following **Five (05) U.G. Programmes only with the intake noted against each from the academic year 2025-2026**, subject to the fulfillment of the conditions as stipulated by the Inspection Commission.

I am, therefore, by direction, to inform you that as per the above decision of the University, provisional affiliation is granted for establishing the above named new self-financing Arts and Science College in the Survey Nos. 153/4B (Manali), 153/5, 153/7B, 153/8A, 154/14, 154/15, 154/16B1, 10/2B (Velur), 10/3, 10/4, 10/5, 197/1A2 (Kurumbal), 197/1B, 197/3A, and 197/3B **(Total 6.35 acres with Permanent Building)** at **No. 3/87 A, Thiruvarur Road, Paruthichery Village, Velur Post, Thiruthuraipoondi Tk., Thiruvarur District - 614 715** for offering the above mentioned **Five (05) U.G. programmes** in the academic year 2025-2026, **subject to the fulfillment of the each and every one of the under mentioned conditions of affiliation prescribed by the University and further to the fulfillment of the conditions of the G.O. first cited.**

SPECIFIC RECOMMENDATIONS OF THE COMMISSION:

- Two separate entrance be established for college immediately
- Separate Playground facilities be created as recommended by the Inspection Commission
- Additional drinking water facilities be arranged immediately
- Separate Library be created for recommended courses with recommended Books and Journals
- Additional few number of computers be purchased immediately
- One additional faculty member be appointed for **B.A., Tamil Programme**
- One additional faculty member be appointed for **B.Com. Programme**
- One additional faculty member be appointed for **B.Sc., Zoology Programme**
- Separate Zoology lab with infrastructure facility be created and lab equipment be purchased as mentioned in the report of the Inspection Commission
- One additional faculty member be appointed for **B.Sc., Artificial Intelligence and Machine Learning Programme** and more computers be purchased with updated software facilities related to the course immediately
- One additional faculty member be appointed for **B.Sc., Computer Science Programme** and separate lab with infrastructure facility be created immediately

SPECIFIC CONDITIONS:

- Books proposed by the Management be procured immediately
- Additional books be procured as recommended by the Inspection Commission
- A sum of Rs. 1,00,000/- be provided for the purchase of books and furniture every year
- Laboratory equipment proposed by the Management be procured immediately

GENERAL CONDITIONS OF PROVISIONAL AFFILIATION:

01. *Each and every recommendations of the Inspection Commission mentioned in its report should be implemented.*
02. *There will be only one section for each of the above programmes and the strength should be limited as indicated against each programme.*
03. *The staff as recommended by the Commission should be appointed immediately subject to the fulfillment of the qualifications, experience, passing of tests and other stipulations laid down by the University for each post and all the posts should be filled up with qualified candidates before the commencement of the programmes.*
04. **The approval of qualification should be obtained from the University for teaching staff including the Principal of the college immediately.**
05. *Arrangements should be made for the conduct of the University examinations for the approved programmes.*
06. *Library and Laboratory should be strengthened as suggested by the Commission.*
07. *The Principal of the College shall make arrangements for the candidates to fulfill the requirements of regulations in respect of attendance for appearing the University examination by conducting extra classes, if need be.*

08. *The extension of provisional affiliation for the programmes now approved should be obtained from the University before admission of students in the programme is made for the subsequent academic years.*
09. *The College shall maintain proper Registers and Records regarding admission, withdrawal, attendance, scholarship, financial transactions, etc. as in the case of other affiliated Colleges of this University.*
10. *The constitution of a Managing Body of the College shall also provide one representative nominated by the Vice-Chancellor to serve on the Managing Body.*
11. *The College shall provide adequate and suitable space for games and physical exercise and shall make adequate arrangements for the physical training of its students.*
12. *If the college proposes for temporary suspension of instructions or closure of U.G/P.G. programmes as per the private college Act must intimated to the University before the commencement of the academic year. The Revival of such programme should be made with prior permission of the University before the commencement of the academic year concerned.*
13. *If any of the conditions of provisional affiliation are not fulfilled by the Management of the College within the specific period fixed therefore, the provisional affiliation shall cease automatically.*
14. *The College shall make adequate provision for the residence of its students not residing with their parents or duly recognized guardians. Such provision shall be in the form of hostel managed by the College and recognized by the University or other hostels recognized by the University.*
15. *Such other conditions as may be prescribed by the University from time to time should also be complied with by the College.*
16. *The college cannot claim this programme is equivalent to Computer Science programme in future*

Further, in case, the Management of the College is not fulfilling any or all the conditions prescribed for provisional affiliation or not complying with any or all the rules of the University or not implementing any decision of the University, it shall be competent for the Syndicate.

- *to suspend the provisional affiliation granted to the College in any programme or programmes of studies;*
- *to decline to entertain any new application for additional affiliation or application for increase in strength in programmes of studies conducted in the College;*
- *to withdraw the affiliation granted to the College in any or all the programmes of studies in which instruction is offered in the College.*

I am to add that another Inspection Commission (preferably with the same members) will **BE SENT** in between December 2025 and February 2026 (i) to review the fulfillment of the above conditions prescribed by the Commission while recommending for Provisional Affiliation for the above Programmes for the year 2025-2026 and (ii) to recommend for extension of Provisional affiliation for the above programme for the year 2026-2027.

The University reserves the right to appoint a Review Committee whenever necessary to verify the fulfillment of any or all conditions stipulated by the University in this provisional affiliation order and the Management of the College shall be subject to the Statutes of the University and the decisions of the Syndicate from time to time pertaining to the conditions of affiliation, recognition, approval, etc.,
