IRS 941 Delinquent Quarterly Reports.pdf;

Mayor and City Councilors,

I am providing an update on two key financial matters that demonstrate the progress made to restore compliance and strengthen the City's financial stability.

The third-party municipal CPA auditor has been scheduled. Sorren has projected completion of the 2022–2023 audit on or before October 30, 2025, and Ben Cohen, our contact at Sorren, has confirmed that the City will receive an **Unmodified Clean Audit**—the highest rating a municipality can achieve. While the audit will include a list of recommendations and improvements, many of these have already been implemented anticipating the 2023-2024 audit to streamline the audit process. It is a point of real pride that the City has moved from two consecutive disclaimers of opinion to the strongest possible audit outcome.

In addition, on **September 5, 2025**, all *18 outstanding IRS Form 941 payroll reports*, left unfiled since 2021, were submitted to the IRS. This corrective action closes a multi-year compliance gap, eliminates the risk of penalties or interest, and brings payroll reporting current for the first time in four years.

The IRS will finalize penalties once the delinquent returns are processed. If a balance is due, available credits from other years will be applied to reduce the liability. Any remaining balance will generate an invoice from the IRS with interest calculated from the original due date and any applicable penalties. This report will be issued directly from the IRS service center that processes the returns. We are actively tracking the processing and confirmation of acceptance, and new procedures are firmly in place to ensure all future filings are completed on time and without recurrence of past omissions.

These corrective measures reflect the goal to resolve longstanding problems, restore fiscal accountability, and reinforce public trust. The City is now on a stronger financial footing, and I will continue to provide updates as further progress is made.
