NEW! Community Dates and Actions for Thornton Pipeline Permit Application

Thornton's Pipeline Permit Application, known as a 1041, has **two** important steps; the Planning Commission step and the Board of County Commissioners step. Each step has two opportunities to voice your concerns; first is a written opportunity, followed by a public hearing opportunity. Citizen input is **vital** at every step.

PLANNING COMMISSION STEP:

1st opportunity is the **Planning Commission documents review**. Rob Helmick, as the Sr. Planner in charge of Thornton's 1041 Application, will make his recommendation to the nine member Planning Commission. The Planning Commission will consider Mr. Helmick's recommendation, along with Thornton's 1041 Application and all citizen comments that have been received by the Planning Commission.

No Pipe Dream's recommendation is that you submit your comments **DIRECTLY** to the Planning Commission, not to anyone else. This must be done by **May 7** to be included in the Planning Commission information packets. 2nd opportunity is the **Planning Commission Public Hearing**. This is the first of only two opportunities for citizens to make public comments. You will likely be limited to three, or maybe even less, minutes to speak. **Date and location is May 16 @ 6:30 p.m. at Larimer County Courthouse, 200 W. Oak Street, Fort Collins.**

After the May 16 public hearing, the Planning Commission will vote on the 1041 Application. The results of their vote and recommendations will be forwarded to the three member Board of County Commissioners.

BOARD OF COUNTY COMMISSIONERS (BOCC) STEP:

The same steps repeat with the three member BOCC, who will make the **final decision**.

1st opportunity is the **BOCC documents review**. The BOCC reviews recommendations received from the Planning Commission as well as letters received directly from citizens. **Letters must be submitted by July 3**, to the Commissioners at <https://www.larimer.org/bocc> This link is also provided on our website.

2nd opportunity is the **BOCC Public Hearing**. This is the final opportunity for citizens to make public comment. You will likely be limited to three, or maybe even less, minutes to speak. **Date and location is July 9 @ 6:30 p.m. at Larimer County Courthouse, 200 W. Oak Street, Fort Collins.**
