

# Westchester Pool Rules 2026

**SWIM AT YOUR OWN RISK - NO LIFEGUARD ON DUTY**  
**NO NIGHT SWIMMING**

1. No lifeguard is on duty, therefore all pool attendees accept that they are swimming at their own risk. Children 12 years of age or under MUST be accompanied by an adult or responsible guardian.
2. Residents must have their key fob in order to gain access to the pool area. Key fob will be deactivated if membership dues are not paid in full. Key fob will not be active until confirmation is made with WHOA Office – Chastine Property Management / 864-640-8137.
3. Please immediately report any issues (eg, biohazards released in the pool, trash overflowing, broken equipment, accidents, disturbances, safety issues, etc) to a member of the recreational facilities committee (see below for contact information) or an HOA board member.
4. The neighborhood pool is not each resident's private pool. Please keep guest numbers to a number that does not disturb others or prohibit other residents from enjoying the pool. The host resident must be present at all times with guests and is responsible for any damage caused by their guests. Please be considerate of the neighborhood resident pool attendees when considering having guests and do not "take over the pool" or disturb residents with private gatherings of outside guests.
5. Parties of any kind are not permitted on Saturday and Sunday between the hours of 12:00 pm and 6:00 pm, as this time is reserved for residents and guests.
6. All organized parties or large gatherings must have prior written approval by the board.
7. Absolutely no night swimming (after dark) or loud gatherings at the pool after hours.
8. No pushing, rough play, running or roughhousing is allowed in the pool area. Residents must self-police any such behavior.
9. Only proper swimwear should be worn in the pool. No cutoffs are allowed.
10. Babies are required to use "swimmies". Absolutely no diapers in the swimming pool.
11. All trash must be placed in receptacles prior to leaving pool area.
12. No pool furniture should be taken outside of the pool/picnic fence or placed within the pool.
13. The association is not responsible for personal belongings or toys left at the pool.
14. No glass containers allowed inside the pool fence or picnic area. Beverages should be consumed from a plastic cup, cans, thermal cups, etc. No food or drink is allowed IN the pool. Please consume items on the pool deck or picnic area only.
15. Be considerate of other people's belongings.
16. Please keep music volume at a level that does not interfere with or disturb others and respect requests to lower the volume if asked.
17. Bathrooms are located inside the clubhouse through the side door. Please make every effort to dry off before entering the building.
18. NO smoking or vaping inside the pool or picnic area at any time.
19. If you are sitting at a table with an umbrella, please lower it prior to leaving the pool in order to prevent potential damage.
