# Long Creek Plantation Pool Rules 2025

## Operating Dates: 05/10/2025 – 09/21/2025 Pool Hours: 8:00 AM – 9:00 PM – Sunday-Thursday 8:00 AM – 10:00 PM – Friday-Saturday

Hours subject to change mid August - September

Hours may vary on weekends

Inclement Weather: The pool closes during inclement weather (remain out of the water for 20 minutes for each thunder or lightning occurrence)

## Pool Use

- Pool privileges are for homeowners and their guests
- An adult resident (18 or older) must accompany all guests. Guest limit is 6 per household.
- Homeowner dues must be current in order to utilize the pool.
- A parent, guardian, or adult resident (18 or older) must accompany anyone 12 years old and under and is responsible for any issues such as cleaning up bathroom accidents.
- A pool FOB will be required to gain entry to the pool.
- Pool FOB's are managed by Chastine Property Management. Issues and questions call 864-640-8137
- There is a cost of \$20.00 for replacement of lost or stolen FOB's and a limit of 1 per household.
- The entry gate must remain closed at all times. Pool FOBs are required for entry.
- The pool is closed outside of published operating hours.
- Anyone in the pool during closed hours will be considered trespassing.

### Pool Rules

- Proper swimwear is required. Jeans or cut-offs are not permitted.
- Swim diapers are required for infants and toddlers.
- No smoking or vaping inside the gated pool area.
- Please use the ash dispenser located outside the entrance to the pool.
- No glass containers in the pool area at any time. Not even in coolers.
- Fines and clean-up charges from DHEC due to glass cleanup will be charged to the Homeowner's account.
- No skateboards, bicycles, scooters, roller blades or skates are allowed inside the fenced pool area.
- No sports equipment that may cause injury is allowed in the pool area, such as footballs, etc.
- No floats over 3 feet by 6 feet are permitted in the pool.
- Clubhouse rentals do not include use of the pool.
- All persons using the pool must do so at their own risk.
- Personal music should be kept at the level for those in the immediate area who are listening to the music.

#### Penalties for Violations

- Repeat offenders may be subject to suspension as determined by the Long Creek Plantation Pool Committee (Reviewed by the LCP Board).
- The LCP Pool Committee will be contacted for appropriate action.
- Unsafe actions may result in pool privileges being revoked.
- Members who trespass on pool property after hours will be suspended for the duration of the pool season.
- Members may also be prosecuted for trespassing.
- Members responsible for any acts of vandalism will be expected to pay for repairs to "like new condition".
- Any acts of vandalism or injury to others will also lead to a suspension for a period determined by the Long Creek Pool Committee (Reviewed by LCP Board).

The pool area is for the enjoyment of families and many of those will be small children. Please keep your conversation and music such that it will not be offensive to families with children at the pool.



Please adhere to all rules/guidelines within this letter and DHEC rules posted at the pool. Use of the pool must be conducted in a safe and responsible manner.
