 - Players will be able to go out by the south side entrance to meet their parents.
 - For the parent/player meeting, Lisa will have the required forms printed. Incoming freshmen have to have the EL1 done. Chip and TJ are working on the details for the physical and the EKGs.
 - We can sell merchandise at the meeting via Villon.
 - Registration fees before spring game is \$250, \$350 after spring break. There is \$250 for volunteer opt-out.
 - A QR code is needed so that we can direct parents to our site for registration.
 - Dave Kressler is still doing parking. Kids cannot collect money for parking unless an adult is supervising
 - Coach Gaudy would like a banner for practice field that incorporates all the sports for Satellite. Chris Braddock will measure and Mike will get quotes for banner.
 - Mural on the side of the field house is approved but the design will need to be approved first with Mrs. Briley.
 - Itinerary needs to be sent to Coach Gaudy and Erica Gaudy for every home game.
 - Expense for Texas Roadhouse gift cards
 - Renewed website, Hudl, Sunbiz, and Turf Tank
 - Uniform expense and golf tournament coming up. Uniform is close to \$40k
 - Funds for parking is going to our video crew
