Storage:

Customers of this facility are hereby notified that storage fees are assessed at the rate of \$85.00 per day when vehicles are left at the facility without repair authorization or without payment for repairs completed.

Estimated date of delivery notice:

The estimated date of delivery and estimated number of days to repair are estimates and may change due to parts or materials delays, inclement weather conditions, insurance related delays, or due to other unforeseen and uncontrollable factors.

Company policy regarding payment:

As the customer, it is your responsibility to understand the policy and your financial obligation of any deductibles and/or services/parts not paid by your carrier. Freehold Collision reserves the right to refuse delivery of a vehicle to a customer until repair bills are paid in full.

By signing this authorization a non-refundable deposit may be required to order parts.

Freehold Collision is not responsible for any personal items left in vehicle during repairs.
