## So many food moves!

### Chef Billy Trudsoe sets June 19 re-opening of Lizzie Keays in Wbg.

Billy Trudsoe, new chef-owner at Lizzie Keays restaurant in Warrensburg, says they will reopen on June 19, serving dinners Tuesday to Saturday.

He said he'd have opened sooner but is still awaiting his state liquor license. He still hopes it'll come through by the opening, but "I can't wait any longer, either way," with staff ready to work.

The Chestertown native who competed in 2022 on Gordon Ramsay's reality show *Hell's Kitchen* said he signed a **one-year lease and two-year op-**

tion with Lizzy Keays owners Tom and Amber Grace.

He's **also the executive chef** since January 2023 at **Basil & Wick's in North Creek**, where he plans to succeed owner Jane Peter, "when that time comes."

"I didn't come out of Hell's Kitchen just to come back and make some decent food," says Chef Trudsoe, 42. "I came back to try to dominate, really set ourselves apart and stand out."

He says Lizzie Keays is "my first solo" restaurant. "I'm basically dumping my whole life savings into this building, my

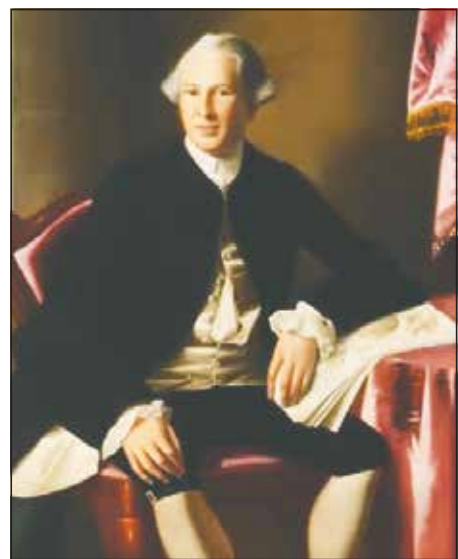

# Nick Chiaravalle plans \$10-million cannabis growing facility in Qby

Queensbury resident Nick Chiaravalle is proposing to construct a 30,084 square foot single-story building for cannabis growing, processing and distribution on Stone Quarry Road in Queensbury.

The 9.05 acre property is situated near the Queensbury Army National Guard recruiting office. The project goes before the town Planning Board with a public hearing on Thursday, June 20 at 7 p.m.

Mr. Chiaravalle's company, Prime Arrow, LLC, purchased the site from Warren County for \$115,000 last November.

"I feel like this site is a distance away from the residents and is a good location," Mr. Chiaravalle said.

He expects the facility will cost around \$10 million to build, and hopes to have it ready to go next spring.

Asked in a follow-up email how he is funding the \$10-million, he replied "debt investment, financial institutions and also open invitation for second round of investors." He said he read about "possible grant money that may be avail for cannabis farmers...but not sure on that."

Mr. Chiaravalle grew up in Lake George and says he lived in California for nine years as an actor. He moved back to New York and worked in the family business — restaurants — before getting into food sales for 14 years, but says his company laid him off during the pandemic.

That's when he transitioned to the cannabis industry. "I just decided to focus on this," he says now. "This was my dream."

Mr. Chiaravalle said that over 25 years ago he was a legacy grower and had a past conviction from that. Now, obviously, the legal landscape surrounding cannabis is much different. Mr. Chiaravalle said that when the state legalized adult-use cannabis just over three years ago, he started building a business plan right away.

"For the last three years I've been putting my heart and soul and savings into just focusing on creating this business of indoor cultivation," he said.

He said he expects to generate 20 to 25 full time jobs in administration and growing, and he's already looking to expand after three years, creating more jobs.

"It will be a fun, healthy environment to work in," he said. "We're doing it right."

So what will go on at the facility?

"We are not a dispensary," Mr. Chiaravalle notes. "We are an indoor cultivation

and distribution facility. Basically we're growing for dispensaries and we would deliver to dispensaries". He acknowledges, "There are no dispensaries around right now in this area." But he says there are already 135 dispensaries in the state.

"We handle all of New York. It's the whole state we deliver to and grow for."

"We're going to be creating organic nutrients, organic soil," he said. "What's out there today is a lot of not-organic product. So our niche is going to be organic flower."

# Amtrak Adk. line won't run this summer

Amtrak's Adirondack Line daily train between Saratoga Springs and Montreal won't run at all this summer, Rep. Elise Stefanik tweeted on X on Tuesday.

**A stoppage of service "on a short-term basis from May 20 to June 30" has been "extended through Sunday, September 8, 2024,"** Rep. Stefanik detailed in reproducing a letter she sent to Roger Harris, the president of Amtrak, and Tracy Robinson, president and CEO of CN, Canadian National Railway.

The letter said in part, "After my continued advocacy, in April 2023 the Amtrak Adirondack Line finally resumed service following its three-year closure that started during the onset of the COVID-19 pandemic. However, just a couple months later in June 2023, you shut down service between Saratoga Springs and Montreal for 79 days citing concerns about the condition of the track...."

"On May 17, 2024, both Amtrak and CN finally announced they reached an agreement to make the track improvements needed to prevent any future summer stoppages of service on the Amtrak

Adirondack Line, stating 'Amtrak and CN Railway are pleased to have resolved the service issues...between Rouses Point, New York and Montreal's Central Station'...

"While the announcement of an agreement...was welcome news, it was short-lived. Amtrak stated, 'Due to anticipated track work Amtrak has modified Adirondack service on a short-term basis from May 20 to June 30 and will only operate between New York City and Saratoga Springs.'

"However, a few short weeks after the announcement of the agreement, the stoppage of service of the Adirondack Line was extended through Sunday, September 8, 2024.

"The continued delays in service and lack of transparency from Amtrak and CN for our Upstate New York and North Country communities is completely unacceptable."

"I request you provide the following information by June 25, 2024"

"1. What is your justification for the continued, significant delays of service and completion of track improvements...

"2. Please provide a rationale for the complete mismanagement and handling of service of the Adirondack line over the past few years.

"3. Please outline a concrete timeline for the resumption of service of the Adirondack Line...to provide our Upstate New York and North Country communities the certainty of service they deserve."

## LGPC nixes LGA hand harvest offer; set on ProcellaCOR

**Pete Menzies**, on behalf of the Lake George Association board, **wrote to the Lake George Park Commission "to reiterate the offer we presented to you on May 28 [to pay] for removal of Eurasian watermilfoil in two Lake George bays this summer**, allowing for a pause in application of ProcellaCOR while our two organizations collaborate on development of a long-term plan for comprehensive management of aquatic invasives in Lake George. We respectfully request your response."

**Lake George Park Commission Chair Ken Parker replied:** "Pete, thanks for the offer to pay for hand harvesting for one year in those two bays. However,

as you are well aware, **the cost is not the sole reason the Park Commission wants to follow the science and apply ProcellaCOR**....[W]hile the Park Commission appreciates the offer to fund the hand harvesting, it respectfully declines.

"The Lake George Park Commission's job as the NYS agency responsible for managing invasive species in Lake George is to evaluate all available management tools and utilize them as best fits the need and the established science. ProcellaCOR has shown itself to be an outstanding new tool to address this invasive species, with results that can greatly exceed our current methods.

"As in all government programs, cost of any action needs to be considered, but cost is not the driving force here.

"Additionally, the Park Commission looks forward to reviewing the actual science regarding ProcellaCOR that the LGA has accumulated over the past two years."

# Amy Fisher Quinn, GF 1988 grad, is new Judge on NYS Court of Claims

Glens Falls High School 1988 graduate Amy Fisher Quinn, who now lives in Lake Placid, has been confirmed as a judge on the New York State Court of Claims.

"For my entire life, my father, who is not with us anymore, but would surely be bursting with pride this morning, told me to listen and learn. And I believe that no advice has ever served me better," Mrs. Quinn told the Senate Judiciary Committee at her June 5 confirmation hearing.

"A good judge must listen carefully to understand the problem at hand and the perspective of the parties before applying these facts to the law."

Her father, Wayne Fisher, who died in 2019, was a long-time fifth grade and special education teacher at Broad Street and Big Cross Street elementary schools in the Glens Falls School District.

Her mother, Kathryn Fisher, was a long-time teacher at Kensington Road and Jackson Heights elementary schools, and still lives in Queensbury.

The state Court of Claims hears lawsuits against the state and certain state entities such as the New York Transit Authority, City University of New York and Olympic Regional Development Authority.

The annual salary is \$232,600, according to the state Comptroller's office.

Fisher was to start work on June 10.

Former Warren County District Attorney Kate Hogan is a judge on the Court of Claims, Saratoga Springs branch.

Judge Fisher said she submitted a 66-page application for the position in February 2023. Gov. Kathy Hochul nominated her as part of 25 judicial nominations at the end of the Legislative session.

In the meantime, Fisher had launched a campaign for an open seat as Essex County Supreme Court Judge, a campaign that she has now dropped.

"I was pleased to answer her (Gov. Hochul's) call," Judge Fisher said in a telephone interview on June 8.

The Senate Judiciary committee without objection recommended confirmation on June 5, and the full Senate confirmed the nomination on June 6.

"I want to commend you for your repu-

tation throughout the district as someone with compassion, a legal mind, and wearing three or four hats all the time," said state Sen. Neil Breslin, D-Albany, who

has a second home on Lake George.

ant governor, representing District 2, spanning New York in the U.S. and Quebec and Ontario in Canada.

Sen. Michael Gianaris, D-Queens, praised Mrs. Quinn's expertise in "restorative justice," an alternative to the traditional "retribution justice" approach.


It aims to repair damage to victims by encouraging perpetrators to take responsibility for their actions. Mrs. Quinn recently went back to law school to complete a restorative justice certification program.

"I think my favorite quote when I studied restorative justice was that Bishop Desmond Tutu said, 'Sometimes we have to stop pulling people out of the river to find out why they're falling in,'" Mrs. Quinn said at her confirmation hearing. "And so restorative justice, when it's used, can really go to the heart of the matter. It goes to the heart of accountability."

Warren County Democratic Chairwoman Lynne Boecher issued a statement saying, "Amy is tenacious, compassionate, personable and fair. She is highly qualified and will be an exemplary addition to our system of justice."

Most recently, Mrs. Quinn had been principal court attorney for Essex County Court Judge Richard Meyer, who is retiring at the end of the year.

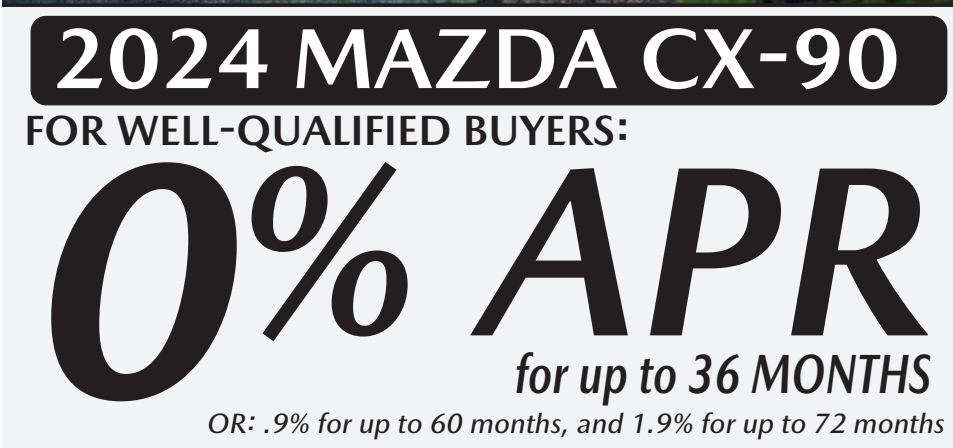

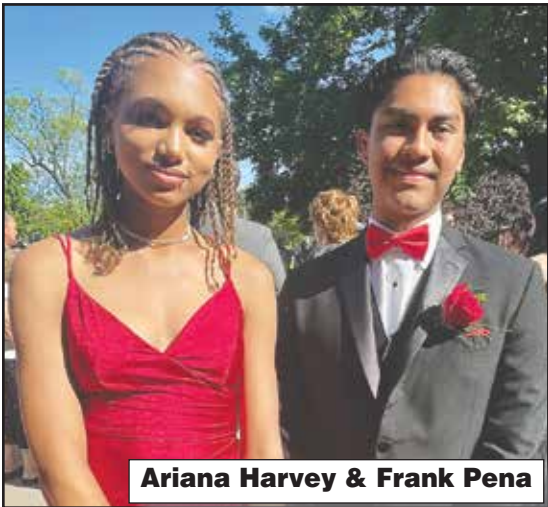

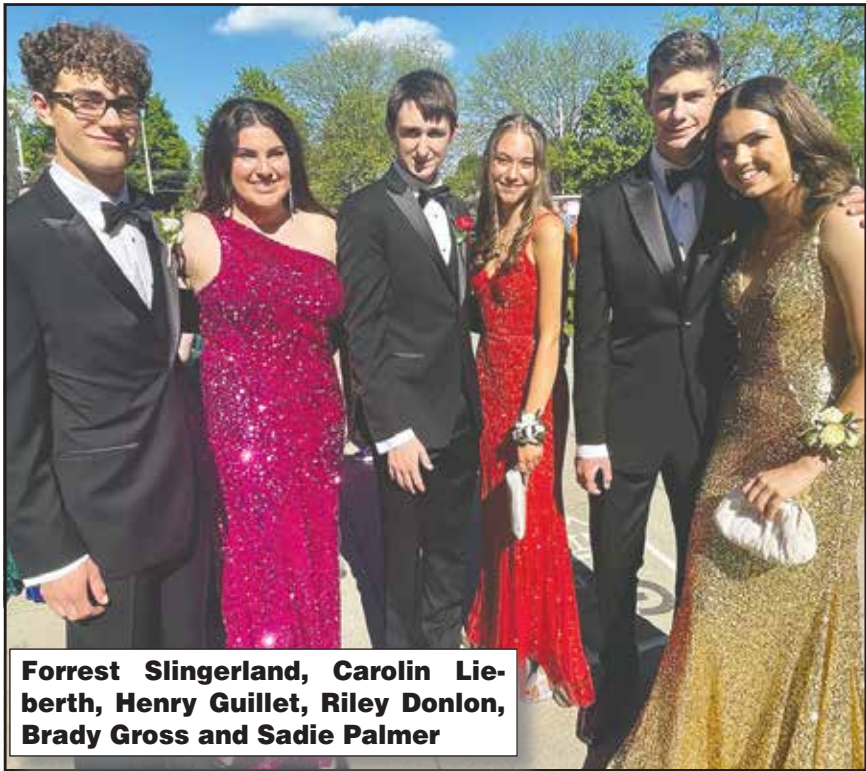

## Tenée Casaccio to Chair Arrow Board; its first woman

Tenée R. Casaccio of Bolton Landing was elected the new chair of the Arrow Financial Corporation Board of Directors, the first woman to serve in that position, said the press announcement from the parent company of Glens Falls National and Saratoga National Banks.



Board Chair William L. Owens stepped down after reaching the mandatory retirement age for directors. Ms. Casaccio is President of JMZ Architects and Planners in Glens Falls, "an established Women-Owned Business Enterprise specializing in higher education planning and design," and "the third-largest architecture firm in (the) Capital Region based on revenue," said the press information.

## With museum nixed here, Shane Newell moves his Jos. Warren items to Connecticut

The Warren County Historical Society said Shane Newell plans to transfer his collection of Joseph Warren paintings and memorabilia to Hillsdale College's Blake Center for Faith and Freedom in Somers, Connecticut.

"WCHS Says Goodbye to Joseph Warren Collection," headlined the Historical Society in a press release Tuesday.

It said it was "deeply disappointed," along with Mr. Newell, in what it termed "the reversal of the County's posture on the Joseph Warren Museum."

The Society had hoped Lake George native Mr. Newell's collection would anchor a Joseph Warren museum here, honoring the county's namesake, the once much-admired, now largely forgotten Revolutionary War leader who lost his life early, fighting in the ranks at Bunker Hill.

"The opportunity for a beneficial heritage tourism site that would have been an economic boon to the County was lost," the Historical Society said.

"The project had garnered support by the Warren County Board of Supervisors over the past three years, led by Supervisors Frank Thomas and John Strough and DPW Superintendent Kevin Hajos."

It noted resistance by "the majority" of Supervisors this spring to the proposed Warren Museum's \$996,000 price tag, to be funded by County Occupancy Taxes.

Without specifically naming Winter's Dream, the Society tied the Supervisors' "reversal" to their concern over "another county Occupancy Tax-funded project in the amount of \$3 million that had not met expectations."

Portions of Mr. Newell's Warren collection have been exhibited at the Warren County Historical Society since 2022, in anticipation of the proposed museum, said the Society. About \$142,000 in County funds, mostly from its American Rescue Plan Act grant, was spent in preliminary designs for the project.

It said Mr. Newell expects his collection will move on display in Boston by 2027, as part of the nation's 250th commemoration of the American Revolution.

# Please Don't Experiment with the Health of Lake George.

The Lake George Park Commission wants to conduct an experiment in Lake George this summer, using a chemical called ProcellaCOR to kill Eurasian watermilfoil. This is an experiment only – an experiment that can wait until all of the risks are fully understood.

The LGPC describes ProcellaCOR as a “next-generation aquatic herbicide” that’s “pretty incredible.” The Park Commission says ProcellaCOR will take “only one drop” and “will kill every milfoil plant while not affecting anything else.” The Park Commission says: “We think we’re ready to give it a try here in Lake George.”

## Really?

Before we experiment, here are the facts:

1. Four towns, a majority of the community, and the lake association that protects Lake George oppose this experiment. Indeed, nearly 9 out of 10 letters recently sent to the Adirondack Park Agency are against the application of ProcellaCOR in the Lake.
2. Putting ProcellaCOR in Lake George is an off-label experiment. Lake George is not the quiescent water body where ProcellaCOR’s own label prescribes it be used to be effective. It is deeper, the water exchange is higher, and the ecology is more complex than the local ponds and small lakes where ProcellaCOR has been tried.
3. The significant horizontal and vertical water currents and transport of Lake George may well sweep ProcellaCOR out of the two bays where its use is planned and carry it to other parts of the lake, bringing unknown impacts with it.
4. The Lake George Park Commission makes much of the fact that ProcellaCOR is “registered” for use by the EPA and DEC. But 95% of the studies submitted to the EPA on ProcellaCOR were conducted by the chemical pesticide industry that’s selling it, and these studies were conducted under very controlled laboratory conditions, with none performed by EPA or DEC.
5. There’s no question that Lake George has a milfoil issue. But it is not a crisis. Hand-harvesting has worked for nearly 40 years. We have a safe, proven alternative to chemical experimentation, and **the Lake George Association has offered to cover the full cost of hand harvesting while alternatives are investigated.**

**The LGA asks the Park Commission and Adirondack Park Agency to accept our offer to hand harvest, put a pause on the ProcellaCOR experiment, and avoid an unnecessary risk to Lake George.**

**Together, we can look for better, safer ways to address Eurasian watermilfoil and other invasives.**

# 14 Stefanik foe Paula Collins, 60, comes out swinging

Paula Collins, the Democrat seeking to oust Republican Congresswoman Elise Stefanik was at the Lawrence Street Tavern Saturday for the Glens Falls Democratic Committee's summer picnic.

The cannabis attorney spoke to *The Chronicle* in an exclusive interview that began with the question, "Why should people vote for you?"

"Because we've got to draw the line right through New York 21 that the ultra MAGA [Make America Great Again, Trump support] nonsense has to stop. We've got to reclaim our democratic values. We've got to stand up for the rule of law."

**Do you think you can win?**  
"I think I can win. Why? Because if I

look at the numbers of registered independents, those people who are registered to vote, but they're not registered as

a Democrat or a Republican, there is a gold mine of opportunity there.

"There are some counties also within New York 21 which, by the way, Franklin County, has more registered Democrats than there are registered Republicans.

"Yet the problem has been getting to those individuals. Get knocking on the doors. My plan is to send six postcards to every registered voter between now and November, because in some cases, that's more contact than they've had with a candidate in years."

**Is it a problem that you've never voted in the district?**

"No, because I have voted in the district. I voted in the primary [April 2]. And let me point out that Elise Stefanik is not, if she qualifies in Schuylerville, she can't vote in the district either. Elise cannot cast a vote for herself."

**Chronicle: I have to check on that, but you've just moved to the district. Is that a problem?**

"That is not a problem, because I've been traveling and working in the district, and as I say, Elise Stefanik has been the representative since 2014 and has never owned property in her own name in the district, and she bought two very expensive townhomes in D.C. Not a single dime of Elise Stefanik property tax

money comes back into New York 21, not on a regular basis."

**Chronicle: You said MAGA people need to be re-educated?**

"It's interesting that they glommed on to that, because I was calling for civics education. And so the fact that it got spun there is kind of interesting. It was a very intimate, very small group on a virtual call, and what's wrong with calling for civics education when the whole rule of law is in question, when Elise Stefanik, who applied for law school, but by the way did not get admitted, is trying to dictate what the judiciary can do.

"We have 12 jurors who have made this decision, not a judge, but 12 jurors. And I'm calling for civics education so that all of us can understand that."

**Chronicle: What don't MAGA voters understand?**

"MAGA voters don't understand that when we have a court system...why do

we even entertain the notion that a person who's been not only indicted multiple times, but also has now been convicted is a worthwhile candidate. Also the whole principle of, for example, calling the District Attorney from New York County all the way down to Washington DC, to answer to Congress. That's something for the Justice Department to handle, not for a congressional committee."

**Chef/baker will open ‘Kitch A Vibe’ at former Juicin Jar in GF**

Chef-baker **Diana Kloepper** will open Kitch A Vibe, a micro-bakery and event space, in the former Juicin Jar at 16 Exchange Street in Glens Falls. She hopes for a “soft opening” by August.

Ms. Kloepper said it will feature small-batch made daily baked goods. “It’s always going to be inspired and fresh and out of the box, but not so far out of the box where people wouldn’t want to try it.”

She said it will also feature small, medium and large charcuterie boards with homemade crackers, local cheeses and meats, and fresh fruit in the summer.

Ms. Kloepper said she’ll seek a license to serve beer, wine and cider.

She anticipates hosting ticketed events a couple times a month and offering the space up for small-scale catered events.

“I want this space to be as much for the community as it is for me,” she said. “I want it to be a hub where everybody feels like they’re welcome there.”

Hours are expected to be 1-10 p.m.

A Long Island native, Ms. Kloepper said she always wanted to live near Lake George. She said she moved to the area in 2016 and has worked as sous chef at The Glen at Hiland Meadows in Queensbury, at Kelly’s Roots in Queensbury and as the sous chef at The Gem in Bolton Landing. Recently she’s been making desserts for Craft on 9 in Glens Falls.

For the past three years, she’s had a side hustle as ‘The Aquarian Culinarian,’ doing pop-up brunches, custom cakes, and private catering, all out of her house.

“It has grown, and there’s a need to occupy an actual space and take it to another level,” she said. “I’ve always wanted to be my own boss and have my own place, so this is literally a dream coming true.”

Ms. Kloepper said the name Kitch A Vibe is a play on the phrase ‘catch a vibe.’

“When I meet with a client, I catch their vibe,” she said. “They are as much of an influence on the creative process as can be. I want them to feel like it’s made for them. I want to create a welcoming vibe for everybody in the community.”

Ms. Kloepper said she has 13 years of experience in the industry — “culinary

ment released by the city in late April in which the public was encouraged to report any dangerous bicycling incidents and to share any information that they had.

Chief Smith and I have been in regular contact monitoring these incidents. I can report that we have both been encouraged by the public response.

Calls and information provided by the public combined with regular patrols have led GFPD officers to interrupt several incidents and resulted in two arrests in April — one adult and one juvenile.

Chief Smith reports that calls began in February (2 calls), ballooned in March and April (13 and 12 calls respectively), but have declined since then. There were six calls in May and there have been three so far in June.

As the number of calls and reports has declined, so has the number of contacts that officers on patrol have had with groups of dangerous riders.

While this is a positive sign, we cannot assume that the problem has been completely eliminated or that the potential for it to balloon again is at zero.

I join Chief Smith in repeating our appeal to the public to report dangerous bicycle riders. Timely and detailed reporting of dangerous riders has helped and will help police officers to identify them — and particularly any “ringleaders” — and get them out of traffic.

“If you see something, say something” and together we can improve the safety of our community.

Taco Kings on South Street to double in size, add 12 tables

Taco Kings Jalisco at 62 South Street is adding 12 tables and doubling in size. Owner Juan Ramirez hopes the addition will be finished in a month, giving customers more space to eat.

"A lot of people say it's too small," he said of the current Taco Kings space.

It's adds restrooms and murals newly painted by Claudia Vinciguerra, featuring items like a piñata, a cactus and famed Mexican painter Frida Kahlo.

Mr. Ramirez, a Mexico City native, opened Taco Kings last October.

Mr. Ramirez said he's been "working a long time — working in Mexico City, making tacos and everything. That's where we got the recipes."

The Taco Kings space, along with the Golden Monkey Lounge next door and apartments upstairs, was redeveloped by Gregg Singer and Larissa Ovitt.

It housed Irish Pizza, which closed in 2017. It was vacant until Taco Kings.

team and myself and my brand.”  
**His brand is “B-True’s Mad Flava”** — combining his nickname bestowed by his basketball coach back at North Country Community College, and a slang term he devised as a young chef, then at the Algonquin, for food that he terms “superb.”

As a *Hell’s Kitchen* alum, he can (and does) call himself a celebrity chef. In person, he serves up equal parts ambition, hometown spirit, energetic enthusiasm, assertive branding and aw-shucks charm.

The Class of 2000 North Warren grad was a three-sport high school standout. He said he scored his 1,000th basketball point as a senior at the then-Glens Falls Civic Center in North Warren’s first trip to the boys’ state championship.

Chef Trudsoe said he started cooking at his grandmother’s side at age 5 and began his career at 13, passing for 16, working a grill at Adirondack Ice Cream in Chester-town, “cooking up burgers and dogs and twistin’ up some *nice* ice cream cones.”

College wasn’t for him, so he got a job washing dishes at The Algonquin in Bolton, working his way up to executive chef by age 21 for “my mentor, Keith Scott.”

“I just loved that team environment,” he says, adding, “I’m also competitive.”

He said he’s cooked and designed menu features at The Garrison in Lake George; Chateau on the Lake, “a great opportunity to elevate my cuisine (beyond) high volume waterfront”; and Blue Water Manor.

He said he was working at a gastropub in Florida when he “got the call” for Hell’s Kitchen on his second try.

“Just a kid from North Warren...**I found myself putting up my signature dish for Gordon Ramsay**, my idol,” he says. “I went through the process and survived with my head still attached. He didn’t rip it off. **“Obviously, I didn’t win,”** ousted in

Episode 5 of Season 21 for chicken wings that did not impress the fiery Mr. Ramsay. Chef Trudsoe still believes in his wings.

**“My number-one seller up at Basil & Wick’s is the B-True Wings.** Those started at the Algonquin probably in 2005. I came up with my own signature sauce. It was my first item on the menu as a young chef.”

Ramsay “only gave me a three, but I’ve only gotten five [star ratings] since. Everybody eats it up, and they say five. Gordon’s palate was maybe off that day, I guess, or maybe he was on some haterade,” Chef Trudsoe laughs.

**“You come out of Hell’s Kitchen and it’s a whole different world,”** Chef Trudsoe says. “You’re on that ultimate high. Life is different after that, for sure, good and bad. You get all that publicity, so fast. And then it’s just kind of you’re in reality, you’re in real life now.

“I wanted to build my brand. I wanted to get a team going. I didn’t really like the situation I was in, in Florida. So I decided to come home and test the waters here,

and basically start from scratch.”

That’s when he joined forces with Basil & Wicks owner Jane Peter.

He says, “It meant a lot because she rolled the dice on me, I rolled the dice on her, and damn, what we created...”

“I hope one day to be able to franchise B-True Mad Flava. Hopefully in 10 years, I have 10 restaurants. When my customers see B-True’s Mad Flava, I want them to think *quality* and...a fun environment to come eat....We want to be the culinary destination spot of the Adirondacks.”

# Crandall talk: Window crashes 3rd biggest cause of bird deaths

With 19 cedar waxwings having died last month after colliding with windows at Crandall Public Library, the library hosted a June 6 talk by John Loz of the Southern Adirondack Audubon Society.

“The goal of today’s talk is...to impress upon you as to how widespread...disastrous...and avoidable” bird collisions are,” said Mr. Loz.

He said window collisions are the third leading cause of bird deaths, behind only loss of habitat and cats.

Mr. Loz said researchers estimate at least **365 million bird window collisions — a million a day — occur every year in the U.S.** alone.

“So,” asked Mr. Loz, “why don’t we see truckloads being hauled away or piles of dead birds under our windows?”

“Twenty to 50% of all window collisions do not leave evidence at all,” he said.

“This leads to people thinking they do not have window kills at their homes.”

Mr. Loz said bird-glass collisions cause concussions and internal injuries.

## How windows can be made safer for birds

“Glass kills, but you can do something about it,” John Loz of the Southern Adirondack Audubon Society told the Crandall Public Library audience.

“Since birds do not recognize glass, you must either physically prevent them from flying into it, or make it a visible barrier for them to avoid.

He said one option is to **hang netting** in front of the windows, or to leave screens in year-round.

The more common choice is to make the glass visible to birds, by **applying decals, stickers, strings, paints, dots, films to the glass** — “anything that the birds can see and avoid.”

Mr. Loz urged “two very important rules...to make this effective.

Rule one is the **“two by four”** — spacing items in a pattern two inches high, four inches wide. “Any pattern using a wider spacing, either vertically or horizontally, will increase the likelihood of a collision.”

Rule two: Anything hung or placed on the glass must be **on the farthest exterior surface** to be fully effective. The reflective quality of glass otherwise masks what’s inside or behind it.

Mr. Loz said enclosed blinds, vertical blinds or other items on the inside can help, “but the outside is best.”

“Good news,” he said: **“The industry**

“The victims fly away to die elsewhere, out of sight and out of mind,” often eaten by “cats, skunks, squirrels, insects.”

“Even if only stunned or slightly injured, many bird-window collision victims fall easy prey to predators.”

Mr. Loz said, “Unlike natural predators...window collisions kill some of the most fit of the population, not just the weak, risking to weaken the gene pool.”

is taking notice of growing demand for solutions and options for bird-friendly products,” some already available for commercial and institutional use. “It’s only time before the homeowner benefits” also, Mr. Loz said.

Some specific products and DIY solutions Mr. Loz described:

- **Acopian bird savers**, or Zen curtains, of thin parachute cord hanging vertically in front of the window, relatively easy to install and clean behind.

- **CollidEscape** is a window film similar to the advertising on busses. “You can see through it from the inside, but on the outside it appears solid. It comes in many colors, and it can also be printed with a pattern, wording or photographs.”

- **The American Bird Conservancy offers ‘feather friendly’ dotted bird tape** in the two-by-four pattern that is “fairly simple” to apply and long-lasting Mr. Loz said.

- **Tempera paint designs** on the window exterior, or even soap, offer a temporary solution.

- **Keep feeders close**, within three feet of your house, Mr. Loz said, so birds cannot build up speed when flying to and fro.

- **Some new windows** come already etched with bird-saving patterns. Current advancements include ultraviolet designs, visible to birds but not humans.

- **Not effective! Single decals**, even in the shape of a predator, he said.

Threats to birds include poisoning, wind turbines, electrocution and oil spills, Mr. Loz said, but “all other types of human-caused mortality do not come close to the death caused by glass.”

It’s just as often “at homes with good habitat and feeders offering food and shelter,” he said.

Anything, from elevated glass walkways and glass walls to even tiny basement windows can cause such collisions.

“Birds are used to flying through tight spaces,” Mr. Loz noted. **“Almost no window is too small to kill.”**

He said that if windows line up across a room, birds see through to habitat on the far side and try to fly there, “often hitting with a terrible and fatal force.”

Or birds will think they are flying into trees or plants reflected in a window.

House plants behind the window will also appear to be an enticing habitat.

“The problem is...**they just do not see glass as an obstacle** to avoid,” he said.

“Why birds matter,” said Mr. Loz: “Birds help to sustain the lives of humans,” for “their physical beauty, their attractive vocalizations, their infinite variety, their widespread distribution, their ease of observation, their fascinating behaviors, and the ecological services they perform — like controlling insects, rodents and diseases, pollinating plants, dispersing plant seeds, providing food for hu-

mans and other organisms, and with our friends the turkey vultures, consuming dead animals. Simply speaking, without birds, humans and many of the world’s other organisms would cease to exist.”  
The Pennsylvania Audubon Society, at [pa.audubon.org](http://pa.audubon.org), has info also, plus a downloadable fact-sheet that covers much of what Mr. Loz discussed.

Crandall’s next step

Crandall Public Library director Kathy Naftaly said the 19 cedar waxwings that died at the library in June struck the north-facing bank of windows behind the birch trees.

She said that normally the library’s lights automatically dim and go out at night, but she suspects carpet cleaning that night kept lights on, perhaps leading to birds flying into windows.

Will the library take any more steps?  
“It has been my call not to have mitigated the windows yet,” Ms. Naftaly said. “Coincidentally the library has contracted with a civil engineering firm to do a once-over of the building. We’ve been in here 16 years,” in the redone building. “They will be looking at what structural things may need some help,” as well as workflow issues.

“This is good timing to bring all this information to the architect and say, What can we do (regarding bird collisions)? This is a good time for all of us to learn.”

“I love that this is happening,” said guest speaker John Loz. “I’m sad for the birds. But let’s take advantage of this lethal thing that happened. Let’s learn from it.”

Saturday's 14-race Belmont Stakes Day at Saratoga Race Course generated an all-sources handle of \$125,748,941, a record for a year in which a horse did not have a bid to win the Triple Crown, the official Belmont Stakes website says.
