- _____ Identification of range users must be presented upon request
- _____ Shooting is allowed from 9:00 AM until sunset unless range or Mill Cove grounds have been scheduled for other use; see website for schedule
- _____ Range **CLOSED** during PA bear and deer rifle seasons, mowing, or other club events
- _____ Target shooting limited to the established shooting range, at appropriate targets situated only on the ground level of the range, and in front of the earth backstop
- _____ Range use is limited to pistols, long guns or archery equipment which are legal for hunting according to the PA Game Commission regulations; no fully automatic weapons are allowed on the Mill Cove range
- _____ Glass or explosive targets are prohibited; all targets, spent brass, used ammunition boxes, and any other items brought to the range must be cleaned up and removed by user
- _____ Violation of range rules, or any other activity deemed by the Mill Cove Range Committee to be unsafe or misuse, may be grounds for termination of range use privileges; no refunds will be considered under these circumstances

RELEASE AND LIABILITY WAIVER:

I acknowledge that I voluntarily have chosen to use the Mill Cove, Inc. (MCI) Gun Range. I am aware that activities performed by members such as myself include using firearms at the shooting range and/or using firearms on MCI property. **I AM AWARE THAT THESE ACTIVITIES ARE HAZARDOUS AND THAT I COULD BE SERIOUSLY INJURED OR EVEN KILLED. I AM VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH KNOWLEDGE OF THE DANGER INVOLVED, AND AGREE TO ASSUME ANY AND ALL RISKS OF BODILY INJURY, DEATH OR PROPERTY DAMAGE, WHETHER THOSE RISKS ARE KNOWN OR UNKNOWN. BY SIGNING THIS DOCUMENT, I AM WAIVING ANY AND ALL LIABILITY ACTIONS WHICH I MIGHT PURSUE AGAINST MCI FOR ANY AND ALL BODILY INJURY OR INJURIES, DEATH OR DEATHS, OR PROPERTY DAMAGE, INCLUDING ANY AND ALL LIABILITY ACTIONS ARISING OUT OF NEGLIGENCE ON THE PART OF MCI, ITS AGENTS, OFFICERS, AND/OR MEMBERS.** In consideration of ONE AND 00/100 DOLLAR (\$1.00) and other good and valuable consideration, including but not limited to being permitted by MCI to become a member and use the gun range, the receipt and sufficiency of which are acknowledged, I forever release MCI, and their respective directors, officers, employees, volunteers, agents, contractors, and representatives (collectively "Releasees") from any and all actions, claims, or demands that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal representatives now have, or may have in the future, for injury, death, or property damage, related to (i) my participation in these activities, (ii) the negligence or other acts, whether directly connected to these activities or not, and however caused, by any Releasee, or (iii) the condition of the premises where these activities occur, whether or not I am then participating in the activities. I also agree that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal representatives will not make a claim against, sue, or attach the property of any Releasee in connection with any of the matters covered by the foregoing release. **I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MYSELF AND MCI, AND I ACCEPT IT OF MY OWN FREE WILL.** I also understand this release and waiver shall remain in effect while I am a member OR GUEST of MCI. **GUESTS ARE THE SOLE RESPONSIBILITY OF THE MEMBER OR MEMBERS WHO BROUGHT THEM TO THE RANGE.
