PART E DATA PROTECTION AND PRIVACY INFORMATION

The Charity is committed to protecting and respecting your privacy. This policy sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it. By signing this agreement you are accepting and consenting to the practices described in this policy.

The Charity is a data controller for the purpose of the Data Protection (Jersey) Law 2005 (the **Law**) (or any subsequent re-enactment).

INFORMATION WE COLLECT FROM YOU

We will collect and process the following data about you:

- Information you give us. This is information about you that you give us by filling in forms such as this or by corresponding with us by phone, e-mail or otherwise. The information you give us may include your name, address, e-mail address, date of birth, phone number, personal description, photograph and information about your physical or mental health or condition.
- Information we collect about you. With regard to each of your visits to our facilities we will collect information about you.
- Information we receive from other sources. For example, your carer or doctors etc.

USES MADE OF THE INFORMATION

We use information held about you in the following ways:

- Information you give to us. We will use this information to carry out our obligations arising from any contracts entered into between you and us, for internal administration purposes and to provide you with the information, products and services that you request from us. We will also use this information to provide you with information about other goods and services we offer that are similar to those that you have already enquired about and to notify you about changes to our service.

- Information we collect about you. We will use this information to administer our records, to measure or understand the effectiveness of the services we offer, the advertising we serve to you and others, and to deliver relevant advertising to you and to make suggestions and recommendations to you and other members about goods or services that may interest you.
- Information we receive from other sources. We will combine this information with information you give to us and information we collect about you. We will use this information and the combined information for the purposes set out above (depending on the types of information we receive).

DISCLOSURE OF YOUR INFORMATION

We will share your personal information with:

- Any member of our group, which means our subsidiaries, our ultimate holding company and its subsidiaries.
- Selected third parties including business partners, suppliers and sub-contractors for the performance of any contract we enter into with them or you.

We will disclose your personal information to third parties:

- In the event that we sell or buy any business or assets, in which case we will disclose your personal data to the prospective seller or buyer of such business or assets.
- If the Charity or substantially all of its assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets.
- If we are under a duty to disclose or share your personal data in order to comply with any legal obligation or to protect the rights, property, or safety of the Charity, our members, or others. This includes exchanging information with other companies and organisations for the purposes of the prevention of crime.

WHERE WE STORE YOUR PERSONAL DATA

The personal data we collect from you may be processed in (including being accessed in or stored in) a country or territory outside your home country, including outside the European Economic Area (“EEA”).

Where we transfer data to another jurisdiction, which does not offer the same level of protection of personal data as may be enjoyed within your home country, we will ensure that your data is appropriately protected.

The primary such transfer of personal data will be to and from the Charity, which is situated in Jersey. Jersey is currently considered by the European Commission to provide an adequate level of protection for personal data.

The Charity will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy. All of the third parties we engage to process your personal information are obliged to respect the confidentiality of your information.

We will retain your personal data for as long as necessary to fulfill the purpose for which it was collected. Once those purposes are completed, we then have legal and regulatory obligations to fulfill in connection with data retention which we will need to fulfill.

Additionally, we may also retain personal data in some circumstances for a period of at least ten years in order to ensure that we are able to answer and deal with any queries, complaints, tax enquiries or investigations or any legal proceedings which may arise.

YOUR RIGHTS

You have the right for confirmation that your data is being processed and to apply for a copy of the personal data we hold about you and to have any inaccurate personal data about you rectified.

In some circumstances you may also have the right to ask us to erase your personal data or restrict its processing. You may also have the right to make a complaint to the local data protection supervisory authority.

ACCESS TO INFORMATION

The law gives you the right to access information held about you. Your right of access can be exercised in accordance with the law.
