

**Resort Village of Aquadeo
BYLAW 11/2023**

A bylaw to permit the operation of golf carts on the public highways within the limits of the Resort Village of Aquadeo.

Subject to and in accordance with, s. 113.1 of *The Traffic Safety Act* and *The Registration Exemption and Reciprocity Regulations (2014)*

The Council of the Resort Village of Aquadeo, in the Province of Saskatchewan enacts as follows:

1. This bylaw may be referred to as the "Golf Cart Bylaw"
2. DEFINITIONS;
 - a. "CAO" – means the Chief Administrative Officer of the Resort Village of Aquadeo;
 - b. "Council" – means the council members for the Resort Village of Aquadeo;
 - c. "Golf Cart" – means a golf cart as defined in *The Registration Exemption and Regulations*. If a golf cart does not meet the definition under the Regulations, then it is not a golf cart
 - d. "Highway" – means any road under *The Traffic Safety Act 2(k)*;
 - e. "Municipality" – means the Resort Village of Aquadeo;
 - f. "Mayor" – means the Mayor of the Resort Village of Aquadeo;
 - g. "Roadway" – means any public roads within the limits of the Resort Village of Aquadeo
3. This Bylaw shall follow the Regulations as set by Saskatchewan Government Insurance (SGI);
4. It shall be lawful to operate a golf cart during the hours between half hour prior to sunrise and half hour after sunset on all public roadways within the limits of the Resort Village of Aquadeo;
5. The owner of the Golf Cart must insure themselves and every other person who, with the owner's consent, operates that golf cart, against liability imposed by law arising out of the ownership, use or operation of that golf cart and provides proof of insurance at the request of a peace officer. The minimum liability requirement is \$200,000
6. The Golf Cart shall display a slow-moving warning device as defined in section 2(1)(kk) of *The Vehicle Equipment Regulations (1987)* and be displayed in accordance with section 10 of the regulations, with one side parallel to and not less than 900 millimeters nor more than 1500 millimeters from the ground
7. Golf Carts must be operated in accordance with the rules of the road in *The Traffic Safety Act* and any other Municipal Bylaw related to traffic.
8. The Resort Village of Aquadeo must monitor and inform Saskatchewan Government Insurance of collision information, including injuries and/or fatalities that involve a Golf Cart.
9. All golf carts must be registered with the Village prior to use within the Village as permitted in the Bylaw.
 - a. Fee of \$50.00 is required upon registration of Golf Cart and made payable to the Resort Village of Aquadeo
 - b. A Yearly renewal fee of \$10.00 shall be required of all registered golf carts;
 - c. Golf carts will be given a registration number that must be displayed on the cart in a visible manner on sides
 - d. Must include the year make and model in the registration;
 - e. Proof of 3rd party liability must accompany the registration;
10. All personal and public liability will be the responsibility of the owners/operator of the said golf cart;
 - a. All golf carts operated must hold the minimum required amount of liability insurance, as per SGI's regulations;
11. Persons operating a golf cart cannot travel on any roadways with a posted speed of over 50 km/h or on any Provincial Highway, except to directly cross it;
12. No persons shall operate a golf cart on the public roadways within the limits of the Resort Village of Aquadeo without a valid driver's license, minimum of class 7(Learner);
13. All Traffic violations shall be enforced by the Royal Canadian Mounted Policy (RCMP)

14. Any person who contravenes any of the provisions of this bylaw is guilty of an offence and liable, on summary conviction, to a fine of not less than \$100.00;
15. This bylaw does not apply to the operation of golf carts that are used solely on the Golf Course.
16. This Bylaw comes into effect on the date of signing and upon approval by Saskatchewan Government Insurance.
17. Bylaw 07/23 is hereby repealed.



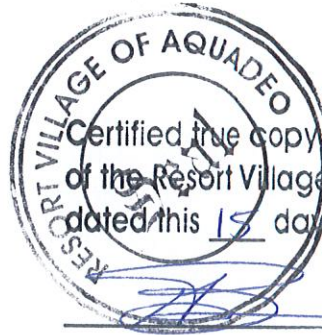
