

RESORT VILLAGE OF AQUADEO

BYLAW NO. 07/2025

A BYLAW TO ESTABLISH A MUNICIPAL CONTROLLED CORPORATION

The Council of the Resort Village of Aquadeo in the Province of Saskatchewan enacts as follows:

1. Short Title

1.1 This Bylaw may be cited as the Municipal Controlled Corporation Bylaw.

2. Purpose

2.1 The purpose of this Bylaw is to direct that articles of incorporation be drafted to secure the incorporation of a municipal controlled corporation to operate for municipal purposes. The objects and purposes of the corporation shall be as follows:

- (a) The ownership, management, and operation of a golf course, marina, and trailer lots including related facilities (e.g., clubhouse, pro shop, and/or event spaces), to foster economic growth, tourism, and community recreation within the municipality;
- (b) The formulation and implementation of programs and initiatives that promote the golf course, marina, trailer lots and any related facilities as a community and economic asset, benefiting residents, visitors, and businesses in the Resort Village of Aquadeo;
- (c) The establishment and maintenance of partnerships with the Government of Saskatchewan, tourism agencies, private businesses, or other organizations to access funding, grants, or promotional programs that support the development and operation of the golf course, marina, trailer lots and any related facilities;
- (d) The establishment and maintenance of communications with other municipalities, regional tourism boards, or recreational organizations to promote the golf course, marina, trailer lots and any related facilities, share best practices, and enhance their role in regional tourism and economic development; and,
- (e) Any other prescribed objects or purposes related to the ownership, operation, or promotion of the golf course, marina, trailer lots and any related facilities that contribute to the economic, social, or recreational well-being of the Resort Village of Aquadeo.

3. Interpretation/Legislation

3.1 In this Bylaw:

- (a) “Act” means *The Municipalities Act*, and amendments thereto;
- (b) “administrator” refers to the Administrator or Chief Administrative Officer of the

Resort Village of Aquadeo;

(c) “council” means council for the Resort Village of Aquadeo.

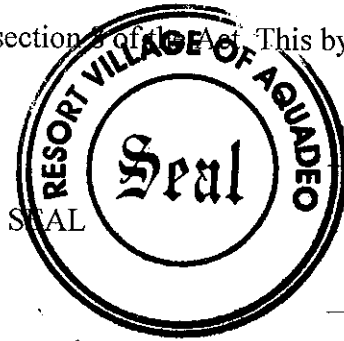
4. Municipal Development Corporation

4.1 Pursuant to sections 4 and 6 of the Act, the administrator or any council member, as appointed by council from time to time, under such further direction and guidance of council as is required, is hereby directed to secure the drafting of articles of incorporation and bylaws necessary to incorporate a municipal controlled corporation pursuant to *The Non-Profit Corporations Act, 2022*.

4.2 The municipal development corporation shall be named: Aquadeo Economic Development Corporation.

5. Coming into Force

This bylaw is enacted pursuant to section 5 of the Act. This bylaw shall come into force and effect on the day of third reading.
