BYLAW NO. 02-2025

A BYLAW OF THE RESORT VILLAGE OF AQUADEO TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER

COUNCIL of the Resort Village of Aquadeo, in the Province of Saskatchewan, enacts as follows:

1. All persons/businesses desiring to be supplied with water from the Municipality's water supply system shall make application to the office of the Municipality. Each application shall be accompanied by the payment of \$7,500.00 for the Capital Water Treatment Plant (WTP) plus a \$2,000.00 fee for the tapping of the water mains and the laying of a service from the water main to the applicant's property line.
2. In the case of private trailer courts and businesses within the boundaries of the Resort Village of Aquadeo, it shall be the registered owner of the trailer court who will make application on behalf of all lots within the boundaries of the trailer court and the registered owner of the business who will make application on behalf of the business.
3. For the purposes of this bylaw, the following definitions shall apply:
 - (a) Deep Line Connection – a water line connection that is operational all year.
 - (b) Shallow Line Connection – a water line connection that is operational only during the summer months from May until September.
4. The charges to be paid by the water consumer whose water service has been connected shall be those set out in Schedule "A" attached. The minimum annual charge shall be payable in every case whether or not any water is consumed.
5. Accounts for water service for:
 - (a) Shallow Line Connections shall cover a calendar year and shall be rendered on or before the 31st day of May of the current year.
 - (b) Deep Line Connections shall cover a calendar year and shall be rendered on or before the 31st day of May of the current year.
6. Accounts shall be paid by December 31 of the current year in which rendered, at which time if they are unpaid, they will be considered in arrears. A penalty of 2% per month cumulative will be added to all arrears.
7. Accounts remaining in arrears at December 31st, may be disconnected from water service and will not be reconnected until all arrears and a service fee of \$500.00 has been paid.
8. Bylaw 03/2024 is hereby repealed.

**SCHEDULE “A”
TO BYLAW NO. 02-2025**

WATER CHARGES

(1) Water Line Connection:

(a) All users – annual charge:

(i) Residential

2026 - \$390.00/year per residence

2027 - \$400.00/year per residence

2028 - \$420.00/year per residence

(ii) Trailer Courts

2026 - \$350.00/year per trailer site

2027 - \$400.00/year per trailer site

2028 - \$420.00/year per trailer site

(2) Water Infrastructure Fee

a. All users – Annual Charge

i. Residential & Trailer Courts

2026 - \$280.00/year per residence

2027 - \$290.00/year per residence

2028 - \$300.00/year per residence

(3) Other water charges:

(a) Bulk water (coin operated)

\$5.00 per 100 gallons
