

**RESORT VILLAGE OF AQUADEO**

**BYLAW NO. 14-2024**

**A BYLAW TO REGULATE MOBILE FOOD VENDING UNITS**

The Council of the Resort Village of Aquadeo, in the Province of Saskatchewan, enacts as follows:

1. Purpose - The purposes of this bylaw is to provide for the control, regulation and licensing of Mobile Food Vending Units within the Resort Village of Aquadeo.
2. Definitions – For the purposes of this bylaw, these words have the following meaning:
  - a. CAO shall mean the Chief Administrative Officer of the Resort Village of Aquadeo
  - b. Mobile Food Vending Unit means a self-contained vehicle (truck or trailer) containing appropriate equipment for the type and method of Prepared Food served, that operates from the parking lane of approved location on a street.
  - c. Municipality means the Resort Village of Aquadeo.
  - d. Prepared Food means food sold by vendors intended for immediate consumption without further preparation/cooking.
3. **License Requirements**
  - a. Every applicant for a License must provide the following information to the CAO of the Municipality:
    - i. Photos and specification of the proposed Mobile Vending Unit;
    - ii. Necessary approval/certification from the Local Health Region;
    - iii. Valid government issued license plate;
    - iv. Liability insurance with a minimum liability limit of \$2,000,000 and name the Resort Village of Aquadeo as an “Additional Insured” party;
    - v. Outline of plan for disposing of fats, oils, greases and grey water.
4. **Operating Requirements**
  - a. Every unit operated in the Municipality must comply with the following:
    - i. Units are not permitted on streets that are primarily residential in nature.
    - ii. Units are allowed to operate on private property, provided the property is zoned appropriately and consent from the landowner has been obtained.
    - iii. Units that are parked on the street must have their vending windows facing the sidewalk. Service windows that face the street are not permitted.
    - iv. Units must be equipped with their own power and water sources. Generators are permitted providing that they do not create a disturbance.
    - v. Units must be kept in a sanitary, well-ventilated, clean condition.
    - vi. Receptacles for waste and recycling must be provided while the unit is in operation.
    - vii. Unit must never be left unattended.
    - viii. Operator must regularly collect and dispose of waste within a 6 metre radius of the unit while it is in operation.
    - ix. Operator must not serve customers in their vehicles.
    - x. Operator must not actively solicit or harass anyone.
    - xi. No smoking within 5 metres of the unit.
    - xii. Operator must not carry on business within 20 metres (measured from the nearest edge of the unit to the property line) of a permanent food service establishment.

- xiii. Operator must not operate unit within 10 metres of an intersection or crosswalk.
  - xiv. Operator must not block access to lanes, driveways, fire hydrants or loading zones.
  - xv. When unit is not in service, it must be returned to private property.
  - xvi. When operating on a public street, providing tables and seating for customers is prohibited.
5. Schedules:
- a. The following Schedules hereto attached form part of this Bylaw:
    - i. Schedule A – Fees
    - ii. Schedule B – Parking Locations
6. Penalty
- a. Any person who violates any provision of this bylaw is guilty of an offence and shall be liable upon summary conviction to a fine of not less than \$200.00 per offence; and
  - b. May be subject to the General Penalties Bylaw
7. Effective Date:
- a. This Bylaw shall come into force and take effect on the formal passing of this Bylaw.
