It's easy to include QH&LS in your estate plan through:

Bequests

Your bequest can be a specific amount or the balance of your Estate. You can make a bequest to QH&LS using the suggested wording in your will. It's a good idea to review this with your professional advisor. A copy of the *Will Wording* can be obtained by contacting us at email admin@quaco.ca

Retirement assets (RRSPs, RIFFs and TFSAs)

You may give all or a portion of an RRSP or RRIF during your lifetime, or name QH&LS as beneficiary.

Life Insurance

To name QH&LS as the beneficiary of your life insurance policy, for details please contact us at email admin@quaco.ca

Charitable Remainder Trusts

You may establish a charitable remainder trust by transferring property (cash, securities or real estate) to QH&LS, which acts as trustee. You retain the right to income from the trust, either for life or a specified term, and the Foundation has irrevocable title to the assets when you pass away.

What types of gifts qualify for charitable tax credits?

Donations of cash, goods, land, or listed securities to a registered charity are eligible for a charitable tax credit. For a donation to be eligible, the transfer of ownership has to be voluntary.
