Applicants from any of the 11 high schools will be eligible. A committee from the Santa Clarita

Valley Scholarship Foundation will select the winners and present a certificate at each high school's awards ceremony. The names of winners will remain confidential until the awards ceremonies. The recipient will be required to send proof of enrollment (12 units or more) before a check will be issued. Awards greater than \$1,500 will be issued in two payments. Proof of continued registration AND previous semester grades showing a GPA of 2.0 or better will be required to claim the second payment. Students will have two years from their graduation date to claim award money. If unclaimed after two years, the money will be reissued to a new scholarship.
