- A. Meeting Called to Order at 6:00pm by Board of Directors President C. Levin

- C. Meeting opened for member comment. No member comments.
- D. Review of Membership and executive Meetings.
 - a. Executive Meeting 1/17/2023 Board concluded that the interior retaining walls are the responsibility of the homeowner. Board also approved Appreciation bonus.'
 - b. Executive meeting 2/14/2023 approved a collections plan template.

- J. S. Brown motioned to contact and use a State Farm preferred vendor to complete the repair inside the Clubhouse. R. Kaye seconded the motion. Motion passed 5-0-0-2.
- K. Resident T. Gutherz reported on the Feral Cat Program. Seven cats participated four males/
 three females spayed or neutered and given shots. We have weekly appointment and are
 working with two vets, but it is still slow going. Instructions to GM to research ownership of
 Feral Cats if being fed by community members. Recommended to check with attorney as to
 steps association can take to curb members feeding and encouraging Feral Cat Program.
