Meeting Minutes - Open Session Meeting

Wednesday, February 12, 2025

- A. Meeting Called to Order at 6:05pm by Board of Directors President A, Hutson
- B. Directors Present: G. Pezzi, B. Wyatt, D. Gomez, B. Cammarota, S. Brown and A. Hutson. Also present was General Manager: S. Cook.

C. Open Forum:

Member discussed a violation was received and expressed that he/she feels that they are being unfairly targeted. Management addressed that more than 30 violations were reported and he was not being targeted in any way and was sorry he felt that way.

Member discussed work that was participated in on the creation of a couple of concrete pads that were created in the community, and the Boards failure to pay for the services. The Board reiterated that prior decisions were based on the materials that were provided at the time; there was no bid, no contract, and it was understood by management that services were being volunteered, as was done on many occasions in the past, per documentation provided by the member.

Pezzi seconded the motion. Motion passed 6-0-0-0-1.

H. Design Reviews:

a. Lot 167 submitted Design Review 2/12/2025. The Board agreed to review Design Review. S. Brown motioned to approve the Design Review to replace the roof with like materials. B. Cammarota seconded the motion. Motion Passed 6-0-0-0-1.

I. Donation of Oak Trees for the Front:

- a. B. Cammarota motioned to allow member S. Brown to donate the Oak Trees he has for planting in the front of the community. S. Brown seconded the motion. Motion passed 6-0-0-0-1.
- b. Discussion ensued regarding trimming the trees and thinning the pond growth. Director B. Wyatt volunteered to assist with this task and has a volunteer form on file in the office.
- c. Kudos were noted that Yard Maintenance has been seen on their hands and knees taking care of common area weeds, and not just skipping by the hard stuff.

J. Reserve Fund CD's:

a. One of the \$50,000 Reserve Fund CD's has matured. S. Brown motioned to allow the Manager to re-invest at a 6-mo CD if the CD rate is better than the cash sweep account that the funds are sitting in providing that the funds are not needed for planned reserve expenses. B. Wyatt seconded the motion. Motion passed 6-0-0-0-1

L. Replacement and disposition of the 2010 Ford Ranger. The Committee Minutes were reviewed. B. Cammarota motioned to purchase a new vehicle as recommended by the committee, small car similar to a Chevy Spark, with less than 50,000 miles, and up to \$11,000 out the door pricing (including tax, license registration fees etc.) should include a warranty, and be purchased Certified Used at a reputable dealership. B. Wyatt seconded the motion. Motion passed 5-1-0-0-1. (dissenting vote S. Brown) The Board authorized management to purchase towing either as AAA towing as a corporate account or on our insurance. The purchase committee was formed with B. Wyatt and Gerald Pezzi, and scheduled to meet Tuesday 2/18/2025 at 11 am.. S. Brown motion to allow management to dispose of the 2010 Ranger via Pedler or other at \$1,100. G. Pezzi seconded the motion. Motion passed 6-0-0-0-1.
