### CITY OF CHICAGO

---

- **City of Chicago**  
The central hub for all municipal services, ordinances, and city programs, including licensing, housing, planning, and public safety.
    - **Introductory Guide to City Services**
  - **Chicago City Council & Ward Offices**  
Legislative body made up of 50 alderpersons, each representing a ward and serving as the primary link between residents and city services, zoning, and local legislation.
  - **Chicago Equity Dashboard**  
A data tool that tracks racial and neighborhood disparities across health, housing, education, and other indicators so policymakers and residents can monitor progress on equity commitments.
  - **Mayor's Office for People with Disabilities (MOPD)**  
Provides programs, advocacy, and technical assistance to ensure Chicagoans with disabilities can access housing, transportation, employment, and city services.

### CHICAGO INITIATIVES

---

- **Chicago \$1.25B Housing and Development Bond Allocation**  
A multi-year city bond package that finances affordable housing, preservation, and neighborhood development projects across Chicago, with a focus on historically disinvested communities.
- **Chicago Community Wealth Building Initiative**  
A city-backed effort to support worker cooperatives, community land trusts, and other shared-ownership models that keep wealth rooted in historically marginalized neighborhoods.
- **Chicago Housing and Development Bond Strategic Plan 2024–2028**  
The City's roadmap for how bond dollars will be targeted, prioritizing specific housing, preservation, and development investments over a five-year period.
- **Executive Order 2024-1: Black Reparation Agenda**  
A directive signed by Mayor Brandon Johnson on June 17, 2024, establishing a formal Reparations Task Force to study the impact of slavery and systemic anti-Black racism in Chicago and develop a comprehensive Black Reparations Agenda with policy recommendations.

- **Missing Middle Infill Housing (Vacant Lots)**

A city initiative that supports building smaller-scale, multi-unit homes on vacant lots to create more affordable, “missing middle” housing options in existing neighborhoods.

- **We Will Chicago (Citywide Plan)**

A 10-year, citywide planning initiative that sets long-term goals around housing, transportation, arts and culture, environment, and equity, built through neighborhood-based engagement.

## **BUSINESS DEVELOPMENT**

---

- **Allies for Community Business (A4CB)**

Provides loans, grants, and free business coaching for small businesses and startups across Chicago, with a focus on historically disinvested neighborhoods.

- **Chicago Business Licensing (BACP Licensing Portal)**

The city’s main portal for securing business licenses, zoning approval, and related permits required to operate legally in Chicago.

- **Chicago Urban League: Center for Entrepreneurship & Innovation**

Supports Black-owned businesses with coaching, training, and technical assistance, including help with business planning, contracts, and access to capital.

## BUSINESS FUNDING & CAPITAL

---

- **Chicago Neighborhood Opportunity Fund (NOF)**  
City of Chicago grant program that uses fees from downtown development to fund small business, retail, and cultural projects along eligible commercial corridors on the South, West, and Southwest Sides.

Corporate program that periodically provides marketing, technology resources, and grants to small businesses, with a focus on diverse-owned and underrepresented entrepreneurs.

Growth-focused accelerator and funding platform that offers revenue-based financing, training, and advisory support to diverse, women, and veteran-led small businesses.

Online platform that partners with corporations and foundations to offer recurring grant opportunities, business funding challenges, and tools for small business owners nationwide.

Bank-led hub of lending products, credit options, and advisory services tailored for diverse-owned small businesses, including access to capital and financial education.

National grantmaker offering recurring micro-grants to women-owned businesses at various stages, with a simple application process and flexible use of funds.

## HOUSING, LAND & PROPERTY

---

- **Chicago Area Fair Housing Alliance (CAFHA)**  
Regional fair housing coalition that works to eliminate housing discrimination, advance fair housing policy, and promote inclusive communities.

- **Chicago Bungalow Association**  
Nonprofit that helps owners of historic Chicago bungalows and vintage homes with grants, technical help, and energy-efficiency improvements, particularly in working-class neighborhoods.
- **Chicago Coalition for the Homeless**  
Provides legal aid, advocacy, and outreach to people experiencing or at risk of homelessness, including support for youth, families, and people in shelters or temporary housing.

City-affiliated entity that creates and stewards long-term affordable homeownership opportunities, often through shared-equity models.

Enforces building codes, issues permits, and maintains safety standards for residential and commercial structures within city limits.

An interactive tool that shows how every parcel in the city is zoned and designated for use, helping residents, developers, and businesses understand what can be built or operated in specific locations.

A city program that helps qualifying homeowners and small landlords address certain municipal debt or code-related burdens so they can stabilize and retain their properties.
- **Community Investment Corporation (CIC)**  
Nonprofit lender that finances the purchase and rehab of multi-family and mixed-use buildings, with a focus on preserving affordable rental housing in Chicago neighborhoods.

An interactive mapping tool that lets residents and businesses explore parcel data, zoning, taxing districts, and other land information across Cook County.

Determines the assessed value of properties for tax purposes and provides tools for researching assessments and filing appeals.

Regulates building permits, inspections, and construction standards for properties in unincorporated Cook County and some suburban areas.

Maintains official land records, deeds, and related documents, and offers searchable databases for property ownership and recorded instruments.

Acquires vacant, abandoned, or foreclosed properties and transfers them to responsible developers and community partners to promote affordable housing and neighborhood revitalization.

Online tool that consolidate parcel-level data including PINs, ownership, assessments, and tax history for properties across the county.

Manages property tax billing, collection, payment plans, and refunds, with online access to tax histories and payment status.

Regional bank supporting member financial institutions with funding and grant programs that help finance affordable housing and community development projects.

State agency that finances affordable housing, down-payment assistance, and rental support programs for residents across Illinois.

Community-based lender providing interest-free loans for housing, emergencies, small business, and education to qualifying residents in the Chicago area.

Offers homebuyer education, foreclosure prevention counseling, affordable mortgage products, and neighborhood stabilization work across many Chicago communities.
- **Rocket Mortgage: Affordable Housing Resources**  
National lender's resource hub for first-time and low- to moderate-income homebuyers, offering educational tools and access to mortgage products.
- **The Resurrection Project (TRP)**  
Community-based nonprofit focused on affordable housing, financial coaching, and community development, primarily on the Southwest Side but serving residents citywide.

## COMMUNITY DEVELOPMENT

---

- **Asset-Based Community Development Institute (ABCD Institute)**  
Research and training center at DePaul University that promotes asset-based approaches to community building, focusing on local strengths rather than deficits.
- **Chicagoland Opportunity Zones Consortium**  
Regional partnership helping communities and investors use federal Opportunity Zone incentives to support equitable development in designated tracts.
- **Chicago Community Loan Fund (CCLF)**  
Community development financial institution offering flexible financing for commercial real estate, small businesses, and community facilities in low- to moderate-income Chicago neighborhoods.
- **Chicago Neighborhood Initiatives (CNI)**  
Nonprofit developer that partners with communities to deliver mixed-use projects, retail, and industrial redevelopment, with a focus on job creation and neighborhood assets.
- **Cook County Community Development Block Grants (CDBG)**  
Federal block grant funds administered by the County to support housing rehab, infrastructure, and community programs in eligible municipalities.



- **Opportunity Finance Network (OFN)**  
National network of CDFIs that expands access to fair, responsible financing for underserved communities and small businesses.

Trade and advocacy group that supports small and minority-owned construction businesses on Chicago's South Side with networking, contracting opportunities, and best practices.

University of Illinois Chicago program that partners with nearby communities on planning, participatory research, and local development projects.

Collaborative initiative led by West Side hospitals and community partners to address health inequities, economic development, and neighborhood investment on Chicago's West Side.

## EMPLOYMENT, TRAINING & REENTRY

---

- **Cara Collective**  
Offers job readiness training, coaching, and transitional employment for people experiencing homelessness or long-term unemployment, with corporate and nonprofit partners across the city.
  - **Chicago Cook Workforce Partnership (ChiCookWorks)**  
Coordinates the public workforce system for Chicago and Cook County, connecting residents to training, job search assistance, and employer programs.
  - **Ladder Up**  
Provides free tax preparation, FAFSA help, and financial coaching for low-to-moderate income individuals and families, helping residents maximize refunds and access credits.
  - **Safer Foundation**  
Provides employment, education, and supportive services for people with arrest and conviction records, helping with job placement and reentry support.

## WELLNESS & COMMUNITY HEALTH

---

- **ACCESS Community Health Network**  
A large network of community health centers across Chicago offering primary care, behavioral health, women's health, and chronic disease management regardless of insurance status.
- **Chicago Department of Public Health (CDPH)**  
City health department responsible for public health policy, community health initiatives, environmental health, and health data for Chicago residents.

## FOOD & BASIC NEEDS

- **Catholic Charities of the Archdiocese of Chicago**  
Offers citywide services including emergency food, rental and utility assistance, case management, senior services, and family support.
- **Greater Chicago Food Depository**  
Cook County's food bank, supplying pantries, shelters, and meal programs across Chicago, and connecting residents to SNAP and other benefits.
- **Nourishing Hope (formerly Lakeview Pantry)**  
Provides free groceries, prepared meals, and mental health counseling at multiple sites and through online ordering and delivery for Chicago residents.

## YOUTH & EDUCATION

- **After School Matters**  
Citywide program offering paid apprenticeships, internships, and enrichment programs for Chicago teens in the arts, sports, STEM, and communications.
- **Chicago Public Schools (CPS)**  
The nation's third-largest school district, serving students across the city and implementing strategic plans such as "Together, We Rise" and the Black Student Success Plan to address equity gaps.

- **Chicago Scholars**  
Supports first-generation and under-resourced CPS students through college access, mentoring, and career development, from high school through college graduation.
- **Chicago Youth Centers (CYC)**  
Operates neighborhood-based centers offering after-school programs, early childhood education, and youth development supports in multiple Chicago communities.
- **CycleBreakers**  
A Chicago-area youth organization focused on mentoring, leadership development, and life-skills training to help young people “break cycles” of violence and instability.
- **Mikva Challenge**  
Engages youth in civic leadership through action civics, youth councils, and policy projects, with strong CPS and community partnerships.
- **My Block My Hood My City**  
Chicago nonprofit that exposes youth to new experiences, supports residents during crises, and leads neighborhood beautification and mutual aid efforts across the city.
- **My CHI. My Future.**  
City initiative that connects young people to out-of-school programs, jobs, and positive activities through a coordinated platform of youth opportunities.
- **Youth Job Center**  
Chicago-based nonprofit that provides job readiness training, placement, and career pathways for young people facing barriers to employment.

---

## VIOLENCE PREVENTION

---

- **Bright Star Community Outreach**  
Bronzeville-based ministry and nonprofit providing trauma counseling, violence prevention, youth programming, and family support through its community center and partnerships.
- **BUILD Chicago**  
West Side-based organization offering violence prevention, street outreach, after-school programs, and mental health support for youth in some of Chicago’s most heavily policed neighborhoods.
- **Chicago CRED**  
Combines street outreach, life coaching, education, and job training to reduce gun violence and create alternative paths for young adults most at risk.
- **READI Chicago (Heartland Alliance)**  
Provides intensive outreach, paid transitional employment, cognitive behavioral therapy, and wraparound support to men most at risk of gun violence involvement.

---

## LEGAL PROTECTION

---

- **Chicago Lawyers' Committee for Civil Rights**  
Focuses on racial equity through legal representation and advocacy in housing, education, voting rights, and economic justice, including small business support.
  - **Chicago Volunteer Legal Services (CVLS)**  
Coordinates pro bono lawyers to provide free legal help in civil matters to low-income Chicagoans, including housing, family law, and consumer issues.
  - **Legal Aid Chicago**  
Offers free civil legal services to low-income residents in areas like housing, consumer issues, public benefits, education, and domestic violence.

Regional transit agency that operates Chicago's bus and rail system, including major expansion projects such as the Red Line Extension and related transit-oriented development planning.
