

## SIX-PART CYCLE EXPLAINER

---

### PURPOSE

---

To outline the Six-Part Cycle, a recurring pattern in which harm to FBAs is recreated through identity dilution, aggregated data, and broad racial frameworks. Naming the cycle interrupts the pattern and protects lineage-specific repair.

---

### WHAT THIS TOOL DOES

---

- Defines the Six-Part Cycle as a structural pattern
- Identifies where harm, drift, or redirection is occurring
- Prevents misclassification and category expansion
- Protects lineage-specific programs from being absorbed into broad racial labels
- Guides institutions in evaluating policy, funding, and reporting accuracy
- Supports Restoration Zone enforcement

---

### THE SIX STAGES

---

**Harm → Partial Repair → Category Expansion → Immigration Shift → Redirection → Rollback**

**1. Harm**

Policies create targeted exclusion, dispossession, or deprivation of FBAs.

**2. Partial Repair**

Limited reforms acknowledge harm but stop short of transferring power or resources.

**3. Category Expansion**

FBA-specific measures widen into “minority,” “Black,” or “POC” categories.

**4. Immigration Shift**

Voluntary-arrival groups enter expanded categories, reshaping outcomes and reporting.

**5. Redirection**

Benefits, representation, and funding flow to groups better positioned within the broad category.

**6. Rollback**

Systems weaken or eliminate even the limited gains once redirection is normalized.

---

## STRUCTURAL STANDARDS

---

**Use:**

- lineage-specific analysis
- structural harm language
- category drift indicators
- policy design terms (redirection, expansion, rollback)

---

**Do Not Use:**

- aggregated racial data as proof of progress
- cultural or behavioral explanations for structural harm
- “minority,” “POC,” or “Black” as substitutes for FBA lineage

---

## PROHIBITED PRACTICES

---

**Institutions **may not**:**

- present aggregated “Black” data when reporting on FBA outcomes
- classify voluntary-arrival groups under FBA-specific harms
- redirect FBA repair to general diversity or equity initiatives
- collapse lineage-specific programs into broad racial frameworks

These practices constitute misclassification and violate USBA alignment standards.

---

## APPLICATION REQUIREMENTS

---

All institutions, partners, and creators must:

- document which stage of the Cycle applies when designing or assessing policy
- disaggregate all data by lineage before applying Cycle analysis

- demonstrate safeguards against drift, expansion, and redirection
- ensure Restoration Zones are insulated from stages 3–6

No program may be described as “FBA-centered” without meeting these requirements.
