# **Graysway Privacy Policy**

# **<u>Ioe Gray Sr.</u>** and **<u>Graysway Insurance</u>** PRIVACY POLICY

<u>Joe Gray Sr.</u> and <u>Graysway Insurance</u> (the "Company") is committed to maintaining robust privacy protections for its users. Our Privacy Policy ("Privacy Policy") is designed to help you understand how we collect, use and safeguard the information you provide to us and to assist you in making informed decisions when using our Tutoring Service.

For purposes of this Agreement, "Site" refers to the Company's website, which can be accessed at www.grayswayinc.com or through your mobile device. "Service" refers to the Company's services accessed via the Site, in which users can engage in academic tutoring, group tutoring sessions, media viewing, or multilingual discussion and discourse.

The terms "we," "us," and "our" refer to the Company. "You" refers to you, as a user of our Site or our Service.

By accessing our Site or our Service, you accept our Privacy Policy and you consent to our collection, storage, use and disclosure of your Personal Information as described in this Privacy Policy.

#### I. INFORMATION WE COLLECT

We collect "Non-Personal Information" and "Personal Information."

**Non-Personal Information** includes information that cannot be used to personally identify you or your child, such as anonymous usage data, general demographic information we may collect, referring/exit pages and URLs, platform types, preferences you submit and preferences that are generated based on the data you submit and number of clicks.

**Personal Information** includes your email, contact information, and voice/image which you submit to us through the registration process at the Site.

## 1. Information collected via Technology

To activate the Service you do not need to submit any Personal Information other than your name, email address, and child academic level. To use the Service thereafter, you do need to submit further Personal Information, which may include: address; child's(ren) academic needs; child's(ren) social and emotional growth areas; language needs; school and educator information; and all else connected to the academic needs, as according to any State Laws and Mandates.

However, in an effort to improve the quality of the Service, we track information provided to us by your browser or by our software application when you view or use the Service, such as the website you came from (known as the "referring URL"), the type of browser you use, the device from which you connected to the Service, the time and date of access, and other information that does not personally identify you. We [GoDaddy Server] tracks this information using cookies, or small text files which include an anonymous unique identifier. Cookies are sent to a user's browser from our servers and are stored on the user's computer hard drive. Sending a cookie to a user's browser enables us to collect Non-Personal information about that user and keep a record of the user's preferences when utilizing our services, both on an individual and aggregate basis. For example, the Company may use cookies to collect the following information:

- Personal information given upon application or submission
- Phone &/or Email address at sign up for access to account

The Company may use both persistent and session cookies; persistent cookies remain on your computer after you close your session and until you delete them, while session cookies expire when you close your browser. For example, we store a persistent cookie to track account usage.

## 2. Information you provide us by registering for an account

In addition to the information provided automatically by your browser when you visit the Site, to become a subscriber to the Service you will need to send a personal email. You can send an email requesting our Service by entering your email address, and detailing the Service needed. By entering, you are authorizing us to collect, store and use your email address in accordance with this Privacy Policy.

# 3. Children's Privacy

The Site and the Service are not directed by anyone under the age of 18. The Site does not knowingly collect or solicit information from anyone under the age of 13, or allow anyone under the age of 13 to sign up for the Service. In the event that we learn that we have gathered personal information from anyone under the age of 13 without the consent of a parent or guardian, we will delete that information as soon as possible. #### II. HOW WE USE AND SHARE INFORMATION

# 1. Personal Information

Except as otherwise stated in this Privacy Policy, we do not sell, trade, rent or otherwise share for marketing purposes your Personal Information with third parties without your consent. We do share Personal Information with vendors who are performing services for the Company, such as the servers for our email communications who are provided access to the user's email address for purposes of sending emails from us. Those vendors use your Personal Information only at our direction and in accordance with our Privacy Policy.

In general, the Personal Information you provide to us is used to help us communicate with you. For example, we use Personal Information to contact users in response to medical or insurance requests, questions, solicit feedback from users, provide Medicare support, and inform families about plans, resources, and community events (or senior focused offers).

We may share Personal Information with outside parties or carriers if we have a good-faith belief that access, use, preservation or disclosure of the information is reasonably necessary to meet any applicable legal process or enforceable governmental request; to enforce applicable Terms of Service, including investigation of potential violations; address fraud, security or technical concerns; or to protect against harm to the rights, property, or safety of our users or the public as required or permitted by law.

## 2. Non-Personal Information

In general, we use Non-Personal Information to help us improve the Service and customize the user experience. We also aggregate Non-Personal Information in order to track trends and analyze use patterns on the Site. This Privacy Policy does not limit in any way our use or disclosure of Non-Personal Information and we reserve the right to use and disclose such Non-Personal Information to our partners, advertisers, and other third parties at our discretion.

In the event we undergo a business transaction such as hiring additional insurance agents, administrators, or a merger or acquisition by another company, or sale of all or a portion of our assets, your Personal Information may be among the assets transferred. You acknowledge and consent that such transfers may occur and are permitted by this Privacy Policy, and that any acquirer of our assets may continue to process your Personal Information as set forth in this Privacy Policy. If our information practices change at any time in the future, we will post the policy changes to the Site so that you may opt out of the new information practices. We suggest that you check the Site periodically if you are concerned about how your information is used.

#### III. HOW WE PROTECT INFORMATION

We implement security measures designed to protect your information from unauthorized access. Your email address is protected and we will not send your advertisement or unsolicited materials. You and your child's(ren) personal information will be safe and secured by a two-step verification through our DNS server and proxy, powered by GoDaddy. We further protect your information from potential security breaches by implementing certain technological security measures including encryption, firewalls and secure socket layer technology. However, these measures do not guarantee that your information will not be accessed, disclosed, altered or destroyed by breach of such firewalls and secure server software. By using our Service, you acknowledge that you understand and agree to assume these risks.

#### IV. YOUR RIGHTS REGARDING THE USE OF YOUR PERSONAL INFORMATION

You have the right at any time to prevent us from contacting you for marketing purposes. When we send promotional communication annually, persons can opt out of further promotional communications by following the unsubscribe instructions provided via email. If Services are terminated, promotional communication will not be rendered. You can also indicate that you do not wish to receive marketing communications from us in your disenrollment documentation, as in from any insurance product without any penalty. Terms of Agreement. Please note that notwithstanding the promotional preferences you indicate by either unsubscribing or opting out, we may continue to send you administrative emails including, for example, periodic updates to our Privacy Policy or your policy.

## V. LINKS TO OTHER WEBSITES

As part of the Service, we may provide links to or compatibility with other websites or applications. However, we are not responsible for the privacy practices employed by those websites or the information or content they contain. This Privacy Policy applies solely to information collected by us through the Site and the Service. To the extent that you access or use the Service through or on another website or application, then the privacy policy of that other website or application will apply to your access or use of that site or application. The Company reserves the right to change this policy and our Terms of Service at any time.
