DRIVER REQUIREMENTS

- Complete Triple M-T Driver Application
- **CDL**-Must have a minimum of 2.5 years experience
- Must be able to pass a Pre-Employment Drug Screen
- No more than 2 violations on MVR for last 3 years
- H₂S Certification Card – Up to Date
- Fit Test Card – Up to Date
- PEC/Safeland/Rigpass Card
- In-house Orientation
- All PPE – Hard Hat, Steel Toed Boots, Impact Resistant Gloves, Eye Protection with Side Shields, Fire Resistant Clothing, H₂S Monitor, Respirator

Driver Guidelines: (ALL DRIVERS MUST BE REPORTED)

Driver w/in guidelines are ages 25-65 w/2 years Class A-CDL experience in the United States and with acceptable MVRS.

Acceptable MVRS are no more than 2 minors moving violations; OR no more than 1 accident; OR no more than 3 non-moving violations (but not in combination with moving) within 36 months.

Drivers to submit for approval with why insured wants to add them:
(Minors being MOVING violations)

Drivers under age 25 or over age 65

Drivers with less than 2 years Class A-CDL exp (including less than 2 years in the U.S.)

Drivers with more than 2 minor violations only

Drivers with more than 1 accident only

Drivers with 1 accident and 1 minor violation is OK, but 1 accident & 2 violations or more need approval

Drivers with more than 3 non-moving violations

(Non-moving violations - IE any equipment violations, oversize/overweight - including unsafe equipment - must determine if driver was responsible for unsafe conditions)

Drivers with any combination of more than 2 moving & 2 non-moving

NO major violations without prior approval (ie. DUI's, drug or alcohol related, driving while license suspended or revoked, speed contest or racing, reckless driving, careless or inattentive driving, leaving scene, any felony conviction, texting or use of computer while driving, hit & run)

Any driver with INT'L license (MX) must have prior approval and must have same age / required experience as above and be verify on the MX website. Must be submitted with DOB, # yrs Exp, Front/Back of license.
