Facilities and Equipment

Our office and training site is located at 3119 Chambers St Suite 5, Venus, TX 76084. We currently have three 10 speed manual transmission tractors: a 2010 Freightliner Columbia Class, 2014 Freightliner Cascadia day cab, and a 2015 Freightliner Cascadia day cab; and two automatic transmissions. A 2018 Freightliner Cascadia day cab and a 2016 Freightliner Cascadia. All our tractors are equipped with a 28-foot trailer. At our facility we practice backing maneuvers, air brake testing, pre-trip inspection, along with additional training inside our classroom.

Admission Requirements

Individuals applying for one of our courses are required to:

- 1. Be at least 18 years of age.
- 2. Have a valid Class C License.
- 3. Have had no DUIs within the past year.
- 4. Have a clean MVR.
- 5. Be proficient in English per the FMCSA.
- 6. Be a U.S. Citizen, or if from Canada or Mexico, residents must have a residency card.
- 7. Provide present proof of Social Security Card and Certified Birth Certificate as part of the requirements to test for CDL through the FMCSA.
- 8. Pass a urine drug screen.
- 9. Pass the DOT Medical Exam.

Daily Class Schedule

Our classes are Monday through Friday.

CDL- Class A Program 160 hours is 8-hours a day with a 45-minute lunch and can be scheduled between 6:30 AM and 4:00 PM. You will receive your class hours Friday before your start date. Throughout the day you will be watching instructional videos, practicing air brakes and pre-trip, working on skills and driving on the road.

CDL- Evening Class A Program 160 hours is 3-hours a day and can be scheduled between 4:00 PM and 8:00 PM. You will receive your class hours Friday before your start date. Throughout the day you will be practicing air brakes and pre-trip, working on skills and driving on the road. You will be required to watch and study our instructional videos each day before you come into class.

CDL- Class B Program 120 hours is 4-hours a day and is scheduled 11:00 AM through 3:00 PM. You will receive a confirmation the Friday before your start date. Throughout the day you will be practicing air brakes and pre-trip, working on skills and driving on the road. You will be required to watch and study our instructional videos each day before you come into class.

CDL- Restriction Removal Program is Monday through Thursday. One to four hours a day depending on the restriction needing to be removed. You will receive your class hours Friday before your start date. You will be required to watch and study our instructional videos each day before you come into class.

Graduation Requirements

ACE's grading system is based on the modules required by the FMCSA for the ELDT training requirement. All modules are graded in a 1-4 grading style for percentages. See below modules and grading levels below. Students are graded daily on the Final week of training and all days are averaged into a final grade at the end of the course. A minimum of 45/56 (80%) is required to graduate. If the final grade is not passing the student will be required more training time in order to be able to test for their CDL.

Remedial Work and Repeated Courses

CDL- Class A Program: If a student is not passing on Monday of the third week, he/she will be notified and given recommendations on how to succeed and extra focus will be given on the subjects the student is failing. If he/she is still not passing by Wednesday of the third week, we will offer an additional week of training.

CDL- Evening Class A Program: If a student is not passing on Monday of the third week, he/she will be notified and given recommendations on how to succeed and extra focus will be given on the subjects the student is failing. If he/she is still not passing by Wednesday of the third week we will offer an additional week of training.

CDL- Class B Program: If a student is not passing on Monday of the third week, he/she will be notified and given recommendations on how to succeed and extra focus will be given on the subjects the student is failing. If he/she is still not passing by Wednesday of the third week, we will offer an additional week of training.

Cancellation and Refund Policy

A refund in the first week will be made to any student who cancels the enrollment contract within 72 hours (until midnight of the third day excluding Saturdays, Sundays, and legal holidays) after the contract is signed. Cancellations must be written and emailed to

Refunds after the 72 hours will be prorated based on the number of days completed in our program.

Attendance Policy

Students are expected to attend all classes in person and be punctual in attending class. Instructors will maintain a positive record of attendance throughout the course. A tardy is defined as arriving more than 15 minutes after the designated time for the beginning of the class or for the continuation of class after designated breaks. Five late arrivals will count as one absence. Leaving early will also be documented in the students file. Any test missed will have to be rescheduled and will count towards a fail.

Dress Code

ACE prepares students for a professional career and believes it is important for each student at ACE to appear well groomed and professionally dressed while on campus or in situations in which you are representing the school. Students should look and act as though they were working in a professional environment. Employers frequently visit the school and in so doing evaluate the appearance of prospective employees.
